# 5.1 City of Victoria Youth Council

- Acknowledging the many initiatives the Youth Council has completed; providing more support by assigning Councillors to Youth Council projects.
- The broad range of initiatives the Youth Council deals with; expanding Youth Council involvement into other areas.

Mayor Helps requested that Councillor Loveday, Youth Council Liaison, report back with Youth Council projects for individual Councillors to consider supporting.

#### 6. DECISION REQUESTS

# 6.1 Pandora / Johnson Cycling Corridors – Public Consultation / Recommended Design

Committee received a report dated June 26, 2015 from Engineering & Public Works that updated Council on the results of public consultation on a proposed bike facility on Pandora Avenue, including two design options and requested Council approval on the design option for a two-way protected bike lane.

#### Committee discussed:

- Concerns regarding access for vehicles making deliveries, parking or dropping off people with accessibility issues in front of City Hall and the McPherson Theatre;
  - As much parking as possible is being preserved;
  - The drop off/pick-up area in front of the McPherson will not be retained but will be relocated.
  - The pick-up/drop off area will be fully accessible and refinements can be made to the design.
  - Consulting with the Executive Director of the McPherson Theatre to determine parking needs.
- Providing Council with a running tally of public and private parking spaces as they increase and decrease.
- The signage, signaling, right and left turns and accepted practices for having two-way bike traffic on a one-way street;
  - How this will look at certain intersections.
- The communications plan that would advise people of these changes.
- The non-cyclists that participated in the public feedback; encouraging new users.
- The options for the separation barrier and why bollards were chosen; enhancing the design with bollards and planters.
- Details regarding how vehicles will park and bus passengers will exit and negotiate the bike path.
- The timeline in terms of issuing RFPs and moving forward with final designs;
   Bringing final designs to Council for their consideration.
- Concerns expressed by downtown merchants with respect to business disruption caused by construction.
- The cost of this project and the suggestion that BC Transit install their bus shelters on the transit islands.
- Noting the efficiency of bike lanes and signals in downtown Vancouver.

#### **Action:**

- It was moved by Councillor Loveday, seconded by Councillor Alto, that Committee recommends:
- 1. That Council endorse the design and construction of a two-way fully protected bike lane with traffic signal changes on Pandora Avenue, and marked bike lanes on Johnson Street.
- That physical separation used in the design be primarily parked vehicles and bollards, with enhanced separation (concrete islands) used at bus zones, mid-block crosswalks, and at the approach to intersections where parking is not permitted.

#### Committee discussed the motion:

- Support for the public engagement strategy that informed this recommendation.
- The detail of the final design and bringing that for Council's review.
- The loss of public realm on Johnson Street if the one-way option on Pandora Avenue was chosen.
- This initiative supports Tourism Victoria's strategic planning with respect to Victoria as a destination for cycling.

- Enhancing the design is an investment in the public realm.
- This initiative makes the road safer for cyclists and motorists.

Mayor Helps advised that she would like the Accessibility Working Group to be formalized and this plan referred to this group.
