F.1 <u>350 Bay Street - Development Variance Permit Application No. 00217</u> (Burnside)

- 4. That the City give consideration to a new sidewalk washroom in the 900 block of Douglas Street area in the 2019 budget.
- 5. That the Mayor write a letter to the BC Transit Commission to support the request for extended late night service.
- 6. That the Mailout Notice be forwarded to the Late Night Advisory Committee to review and make recommendations on wording to ensure that those most

affected have the opportunity to express whether or not here are any concerns with the application.

F.2 <u>1415 Broad Street - Application for a Permanent Change to Hours of</u> <u>Service for a Liquor Primary License for the Victoria Event Centre</u>

Councillor Lucas withdrew from the meeting at 9:07 a.m. due to a pecuniary conflict of interest with the following item, as she is the general manager of a hotel.

Committee received a report dated July 11, 2018 from the Director of Sustainable Planning and Community Development regarding an application by the Victoria Event Centre to change their Liquor Primary License service hours from 5:00 pm - 1:00 am to 9:00 am - 2:00 am at 1415 Broad Street.

Committee discussed:

- A potential mechanism to have windows close at a certain time.
- Potential noise bylaws that could be put in place in the future.
- Implications with the provincial license with the operator.
- The cost and time required for the application.
- The impact to downtown in terms of policing and cleaning.
- The idea that this is a performance venue and not a nightclub.
- Potential bylaws that could manage noise levels.
