## Storefront Cannabis Retailer Regulation Bylaw No. 19-053:

The City of Victoria Council is considering the adoption of the *Storefront Cannabis Retailer Regulation Bylaw, 2019 – No.19-053.* Council will be considering licensing and operating conditions for storefront cannabis retailers. If adopted, the Bylaw will replace the *Cannabis-Related Business Regulation Bylaw,* which contains licensing and operating conditions for cannabis-related businesses, including storefront retailers, which is now governed under federal and provincial rules. Overall, there would be no reduction in regulations but rather a shift to federal and provincial responsibility for many of these matters.

Anticipated impacts are based on previous experience with the site which provided licenced service while operating as Prima Strada. The proposed hours of operation and occupant load are not expected to result in negative impacts to the community.
- b. If the application is approved, the impact on the community is expected to be positive economically as the approval supports the business's operating model and presumably the long term viability as a local business.
- c. The views of residents were solicited via a mail out which included 89 letters to neighbouring property owners and occupiers within 100 metres of the licensed location and a notice posted at the property. The City received one letter in response to the request and the Burnside Gorge Community Association has not provided correspondence.
- d. Council recommends the license endorsement be approved.
