A BYLAW OF THE CITY OF VICTORIA

The purpose of this Bylaw is to amend the Vehicles for Hire Bylaw

Under its statutory powers, including sections 146-150 of the *Community Charter*, the Municipal Council of the Corporation of the City of Victoria enacts the following provisions:

1. This Bylaw may be cited as "VEHICLES FOR HIRE AMENDMENT (No. 20) BYLAW No. 20-010".
2. Vehicles for Hire Bylaw No. Bylaw No.03-060 is hereby amended by repealing sections 40 to 70 inclusive, and sections 72 to 74 inclusive.
3. Repeal definitions for taxi meter and taxi owner
4. Repeal definition of limousine and replace it with:

“limousine”

means a motor vehicle

- (a) that does not show a sign or mark indicating that it is a cab or taxi,
- (b) that does not have a dome on its roof, and
- (c) whose owner or operator does not claim or represent that it is a cab or taxi;

READ A SECOND TIME the **9th** day of **January** 2020.

READ A THIRD TIME the **9th** day of **January** 2020.
