WHEREAS local governments in British Columbia are integral for the implementation of the Truth and Reconciliation Commission (TRC) of Canada Calls to Action, Murdered Indigenous Women, Girls and Two-Spirit People, (MMIWG2S) Calls for Justice, and the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) but have the least resources to do the work meaningfully.

AND WHEREAS local governments are committed to advancing truth, justice, and reconciliation, and understanding that each Aboriginal community has different and diverse histories, making local context and consultation critical to meaningful action;

THEREFORE BE IT RESOLVED THAT UBCM call on the Province of British Columbia to provide support and equitable access to funding for trauma-informed, Indigenous-led education, training, and policy guidance for local governments and associated law enforcement and emergency services to implement municipalspecific recommendations from the TRC, MMIWG2S, and UNDRIP.

WHEREAS the opioid crisis and mental health challenges affect at least 1 in 5 BC residents and has been compounded by the COVID-19; at the same time, evidence shows that access to upstream services such as counselling related specialties and physical/occupational therapy decreases opioid use and/or provides better health intervention outcomes, but these are not accessible to many residents as they are not covered and are much too expensive through fee for services:

WHEREAS communities are currently struggling to meet the needs of our residents, between funding of community programs and increased mental health calls for first responders, which already comprise between 20-30% of local government expenditures and are not often the most appropriate service to support people in crisis;

THEREFORE BE IT RESOLVED THAT UBCM request that the Province expand access to and funding for allied health professionals, particularly mental health counselling specialties, and physical/

occupational therapy related specialties, through expansion of team-based care through not-for-profit delivery including community health centres, available to all BC residents regardless of their immigration status and income, throughout the province.

AND that the Province of BC increased support and funding for Peer Navigators as part of the BC Mental Health and Addictions Strategy.

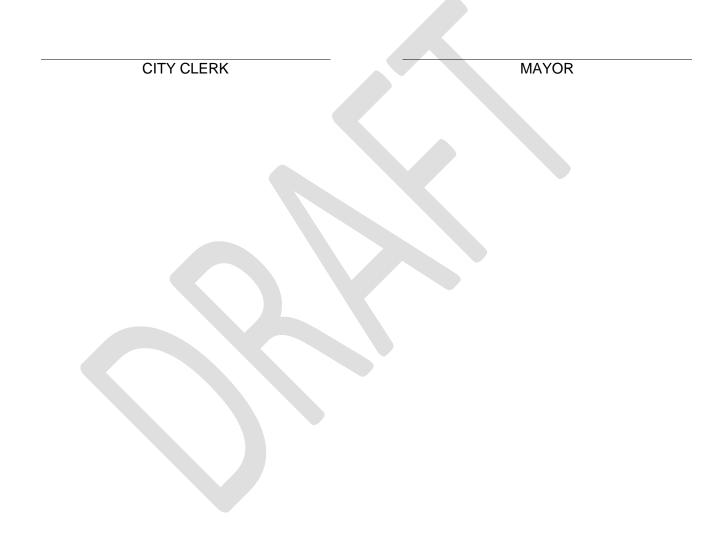

A BYLAW OF THE CITY OF VICTORIA

The Council of the Corporation of the City of Victoria, in an open meeting assembled, enacts the following provisions:

Title

1. This bylaw may be cited as the "Council Procedures Bylaw, Amendment Bylaw (2021) No. 21-074".

- 2. The Council Procedures Bylaw No. 16-011 is amended as follows:
 - Section 7 is repealed and replaced with the following section:
 - "7 (1) Council must establish and the City Clerk must make available to the public a schedule of the date, time and place of regular Council meetings.
 - (2) The City Clerk must give notice of the availability of the schedule referred to in subsection (1), at least once a year in accordance with section 94 and 127 of the *Community Charter*."
 - (3) At least 48 hours before a regular Council meeting, the City Clerk must give advanced public notice of the date, time and place of that meeting by
 - (a) posting the agenda at the public notice board at City Hall,
 - (b) delivering copies of the agenda to each of the member of Council, and
 - (c) leaving copies of the agenda at a public counter at City Hall for the purpose of making the agenda available to members of the public."

 - (2) Two members of Council may participate electronically in a Council meeting if:

- (a) at least 24 hours before the meeting those members notify the City Clerk of their intention to participate electronically, and
- (b) A majority of the members of Council are physically present at the meeting.
- (3) Notwithstanding subsection (2), the Mayor may authorize more than two Council members to participate electronically provided that:
 - a state of local emergency has been declared by the City and in person participation in the Council meeting would be inconsistent with the declaration; or
 - (b) in the Mayor's opinion extra-ordinary circumstances exist that make it unsafe or impractical for Council members to physically participate in a meeting.

and for clarity, subsection 2(b) does not apply to a meeting authorized by this section.

- (4) Written material at a meeting at which there is electronic participation, if that material is presented to the meeting without being included in either the agenda package or late agenda items sent to the members participating electronically must be audibly read into the record.
- (5) A member, who is participating electronically in the voting on a matter, must vote by audibly stating that they vote in favour or oppose.
- (6) If there is an interruption in the communications' link to a member who is participating electronically, the other Council members may
 - (a) decide on a short recess until it is determined whether or not the link can be re-established, or
 - (b) continue the meeting and treat the interruption in the same manner as if a member who is physically present leaves the room."
- (3) Section 15 is repealed and replaced with the following section:
 - "15 (1) Particular business at a regular Council meeting must be listed on the agenda and taken up in the following order, unless Council resolves otherwise or there are no matters under an item for consideration at that meeting:
 - (a) Approval of Agenda;
 - (b) Reading of Minutes;
 - (c) Requests to address Council (maximum 6 requests);
 - (d) Proclamations:

- (e) Public and statutory hearings (including third reading or adoption of bylaws and approval of permits where applicable after each hearing);
- (f) Requests to address Council;
- (g) Unfinished Business;
- (h) Reports of Committee;
- (i) Notice of Motions;
- (j) Bylaws;
- (k) Correspondence;
- (I) New Business;
 - (i) Late items;
- (m) Question Period;
- (n) Closed meeting, if required;
- (o) Adjournment.
- (2) Council may proceed with a particular item of business at a regular Council meeting in the absence of the Council member in whose name the item is listed on the agenda only if that member has given written permission for another Council member to proceed with that business.
- (3) Prior to each Council meeting the City Clerk must prepare an agenda setting out all items for consideration at that meeting, noting in short form a summary for each item on the agenda.
- (4) The deadline for submissions by the public to the City Clerk of items for inclusion on a Council meeting agenda is 11:00AM on the day before the meeting.
- (5) Council must not consider any matters not listed on the agenda unless introduction of the late item is approved by Council at the time allocated on the agenda for such matters.
- (6) If the Council makes a resolution under subsection (5), information pertaining to the late items must be distributed to the members."
- (4) Subsection 28(1) is repealed and replaced with the following subsection:
 - "(1) Only by an affirmative vote of 2/3 of the Council members present may a daytime Council meeting continue after 4:30PM, or an evening Council meeting continue after 11:00PM."

(5) Section 40 is repealed and replaced with the following section:

"Adjournment of Committee of the Whole meetings

- 40 (1) Regular Committee of the Whole meetings must adjourn at 2:00PM unless a motion for continuation is approved by 2/3 of the members present.
 - (2) A motion for continuation under subsection (1) must establish a specific time for the adjournment of the Committee of the Whole meeting."
- (7) Subsection 42(2)(b) is repealed and replaced with the following subsection:
 - "(b) section 7 [Schedule and public notice of meetings];"

Dear Mayor Helps:

Thank you for your letter of July 9, 2021, regarding the release of accused persons on bail.

In my role as Attorney General, except in the most extraordinary circumstances, I am not involved in individual cases, nor do I have authority over the judiciary. Under our system of law, the judicial branch of government is separate and independent from the executive branch of government.

In your letter, you ask about options for keeping accused in custody. Within 24 hours of their arrest, arrested persons must be released or be brought before a judge for a bail hearing. "Judicial interim release," also known as bail, occurs when a judge or justice releases an accused into the community, with or without conditions, after a charge has been laid and pending trial. Under our system of law, accused persons, even those facing serious charges, have the right to be presumed innocent until proven guilty according to law in a fair and public hearing by an independent and impartial tribunal. This principle is fundamental to the right, guaranteed under s. 11(e) of the *Canadian Charter of Rights and Freedoms*, not to be denied reasonable bail without just cause.

As your letter notes, Parliament has directed the courts to exercise a "principle of restraint" in bail hearings, and give primary consideration to the release of the accused at the earliest reasonable opportunity, on the least onerous conditions that are appropriate in the circumstances and are reasonably practicable for the accused to comply with (*Criminal Code*, s 493.1).

For most offences, an accused person can only be detained in custody pending trial if the Crown can satisfy the Court that detention is necessary to secure the accused's attendance in court, to ensure the protection or safety of the public, or maintain confidence in the administration of justice, pursuant to s. 515(10) of the *Criminal Code*. In most circumstances, Crown Counsel bear the burden of proof to show that an accused should be detained.

An accused can be released on conditions that are intended to protect the public, including terms that allow for close monitoring through bail supervisors, police or a private person known as a surety. Pursuant to s. 515(13), judges are required to consider the safety and security of every victim of an offence when making release orders. The form of bail used in a particular case will depend on the nature of the offence the accused is alleged to have committed, the background of the accused, and the risk the accused would present if released. Non-compliance with a term of bail can result in a new charge for breaching bail, a revocation of bail, or both.

Judges, in determining bail, are bound by the legal and procedural rules laid out in the *Criminal Code*. Bail provisions under the *Criminal Code* are the responsibility of the federal Department of Justice and may only be amended by the federal government. If you are of the view that the *Criminal Code* provisions related to these matters require amendment, you may wish to share your views with the Honourable David Lametti, Minister of Justice and Attorney General of Canada. Minister Lametti is responsible for proposing such amendments to Parliament and may be reached at:

In your letter, you also refer to matters of public safety as well as resourcing for police to support accused who are released in the community. The Ministry of Public Safety and Solicitor General has administrative responsibility for policing and public safety. Accordingly, the Honourable Mike Farnworth, Minister of Public Safety and Solicitor General, has been copied on this correspondence for his consideration.

Please be assured that in cases involving crimes where public safety is at risk, the importance of the protection of the public is taken into full and proper consideration. We know that an integrated approach is necessary to address the factors that contribute to prolific problematic behavior and justice, health, social services and community partners must work together to support timely and coordinated access to support services. The Ministry of Attorney General is committed to working towards this goal within the scope of our legal authority.
