1. Rezoning Application No. 00473 for the Easterly 300 Block of Tyee Road and the Westerly 300 Block of Harbour Road (Undeveloped Lands as Dockside Green)

#### 1. Public Hearing

### Official Community Plan Bylaw, 2012, Amendment Bylaw (No. 16) No. 17-007

The purpose of this Bylaw is to amend the Official Community Plan by adding new design guidelines (the "Dockside Green Urban Design Guidelines (2016)" and the "BETA at Dockside Green Design Guidelines (2016)") to Development Permit Area 13: Core Songhees that will apply to the development of certain lands within the area marked "Dockside" in Map 64 of the Official Community Plan, and to exempt the subdivision of lands within the area marked "Dockside" in Map 64 of the Official Community Plan from the requirement for a Development Permit provided the subdivision is consistent with the Subdivision Plans set out in Appendix A to the Dockside Green Urban Design Guidelines (2016). The new Design Guidelines and the exemption of subdivisions from the requirement for a Development Permit will apply to the lands legally described below in the notice concerning Zoning Regulation Bylaw, Amendment Bylaw (No. 1076) - Bylaw No. 17-005, and which are also shown outlined in the accompanying map.

### 2. Zoning Regulation

The purpose of this Bylaw is to amend Part 12.9 – CD-9 Zone, Dockside District, of Bylaw No. 80-159, the Zoning Regulation Bylaw, by deleting sections 1 through 13, as well as Schedules A and B, and substituting the Regulations and Schedules set out in Appendix 1 to Bylaw No. 17-005. The Bylaw will alter the CD-9 Zone Regulations only as they apply to the lands shown outlined in the accompanying map, the legal descriptions are:

Jim Handy (Senior Planner): Advised that the application is to permit additional uses, increase permitted floor area, and amend the applicable design guidelines through amendments to the Official Community Plan Bylaw, Zoning Regulation Bylaw, and Land Use Procedures Bylaw.

Norman Shearing (President of Dockside Green): Provided information regarding the application, which aims to create sustainability, public amenities, and affordable housing.

Ally Dewji (Director of Development): Provided information regarding the application by outlining the community engagement that has been undertaken.

Derek Lee (Project Manager): Provided information regarding the application by outlining the current design aspects of the application.

<u>Ally Dewji:</u> Provided information regarding the application by further outlining the amenities package, green buildings, transportation infrastructure, and advised that there will be ongoing consultation with the community as future applications are brought forward.

<u>Sarah Shams (Colwood Resident):</u> Expressed support for the application as it provides environmental sustainability, positive initiatives, and affordable housing.

<u>Dan Hill (Burnhill Court):</u> Expressed support for the application as it will be a good addition to the City and create affordable housing.

Morning Henderson (Cedar Avenue): Expressed support for the application as it will create affordable housing and environmental sustainability.

Nicole (Business Development and Community Outreach Manager for Modo the Car Co-Op): Expressed support for the application as it will help create a walkable, car-free community.

<u>Nigel Deacon (Wharf Street):</u> Expressed concerns regarding the application, as the emphasis on the environment is no longer a priority.

Caleb Behrs (Resident): Expressed support for the application as it will help to create a great City.

<u>Joshua Samaldi (Haldi Place):</u> Expressed support for the application as it will create affordable housing, will provide community amenities, and add to the local economy.

<u>Joy McDonald (Admirals Road):</u> Expressed support for the application as it is a supporter of the arts, and creates community amenities.

<u>Kathleen Williams (Sitkum Road):</u> Expressed support for the application as affordable housing and development will be positive in Victoria West.

Robert Brown (Harbour Road): Expressed support for the application as it will help create further affordable housing.

Robin Quinn (Saanich Resident): Expressed support for the application as it will create housing that is appealing for the growing technology industry.

<u>Christine Collins (Newton Street):</u> Expressed support for the application as it incorporates green space, sustainability, accessibility, and mixed use housing.

<u>Doug Kelly (Sitkum Road):</u> Expressed concerns regarding the application, as the 2005 application was preferable.

<u>Willie Waddell (Tyee Road):</u> Expressed support for the application as it will create affordable housing and it will create an inclusive community.

<u>Michael Hawkins (Tyee Road):</u> Expressed concerns regarding the application as inclusive, affordable housing needs to be considered.

<u>John Rose (Sitkum Road):</u> Expressed concerns regarding the application ,as the 2005 application was preferable.

<u>Keith Dewie (Tyee Road):</u> Expressed support for the application as more development should take place, and the developments should meet LEED standards.

<u>Lee Tucker (Ware Road):</u> Expressed support for the application as it will create more green energy management and community amenities.

Resolution: Extension of Vacancy Taxation Authority and Additional Property Transfer Tax to Capital Region

WHEREAS the Government of British Columbia and Legislative Assembly responded to a housing affordability crisis in July 2016 by introducing a 15% Additional Property Transfer Tax on residential real-

estate purchases in Metro Vancouver by foreign entities – a policy that has helped curb rapid escalation of residential real-estate prices in that region;

AND WHEREAS the same legislation empowered the City of Vancouver to introduce a vacancy tax on residential properties;

AND WHEREAS there is a risk that application of these policies in a single region can create distortions in the real-estate market in other regions, including in the Capital Region, with a negative impact on housing affordability;

AND WHEREAS local government jurisdictions within the Capital Region have experienced sharp escalation in real-estate prices and land values in the past year, as well as growth in purchases by foreign entities since the Additional Property Transfer Tax was introduced in Metro Vancouver, undermining the Capital Regional District's Board Strategic Objective of increasing the supply of affordable housing;

THEREFORE BE IT RESOLVED THAT the Capital Regional District places itself on record requesting that the Government of British Columbia introduce legislation without delay to: (1) Extend Vacancy Taxation Authority to local governments within the Capital Region, and (2) Apply the 15% Additional Property Transfer Tax to purchases of residential real-estate by foreign entities in the Capital Region and utilize this increase to invest in affordable housing;

AND BE IT FURTHER RESOLVED THAT the Capital Regional District requests that purchases by individuals who live, work or pay provincial income tax in British Columbia be exempted from application of the Additional Property Transfer Tax;

AND BE IT FURTHER RESOLVED THAT the Capital Regional District requests that the Government of British Columbia introduce additional measures to curb speculation in residential real-estate and increase housing affordability in the region and province.

Resolution: Extension of Vacancy Taxation Authority to Local Governments

WHEREAS the Government of British Columbia and Legislative Assembly responded to a housing affordability crisis in July 2016 by introducing legislation that empowered the City of Vancouver to introduce a surtax on vacant residential properties;

AND WHEREAS communities across British Columbia face acute housing affordability pressures, while a portion of the housing supply in all communities remains vacant, including properties that have remained derelict for years or decades;

AND WHEREAS vacant and derelict buildings pose substantial risks in terms of public safety in communities, as well as liveability and desirability for nearby and adjoining neighbourhoods and properties;

THEREFORE BE IT RESOLVED THAT the Province of British Columbia extend the authority to introduce a surtax on vacant residential properties to local governments across British Columbia, providing communities with the discretion to introduce taxation tools to discourage vacant and derelict buildings, and encourage the improvement of buildings to address housing affordability.
