1. <u>BC Lottery Corporation Request for Expressions of Interest for Siting of New Casino Facility - Phase Two</u>

Council received a report dated June 13, 2016, from the Director of Sustainable Planning and Community Development regarding further information on the proposed scope and selection process for a casino.

Council discussed the following:

- Previously discussed plans for the Crystal Gardens.
- Potential issues in regards to noise concerns and existing noise bylaws.
- Staff's decision behind putting forward Crystal Gardens for consideration.
- The potential to have staff discuss cooperation with Saanich, in regards to a new casino facility.

It was moved by Mayor Helps, seconded by Councillor Lucas, that Council direct staff to submit a response to BCLC in accordance with Attachment 2 to the Request for Expression of Interest - Phase Two for their consideration and which includes the site identification and promotion of the City-owned Crystal Gardens and Apex site as a potential site for consideration by BCLC.
