Option 1 (Recommended)

The report recommends Council approve all three Victoria Housing Reserve Fund applications (totaling \$2,180,500), subject to:

- Execution of a Housing Fund Grant Agreement (80% and 20% allocations).
- Execution of legal agreement securing affordability for 60 years.
- Victoria Housing Reserve Fund Guidelines requirements met.
- Development permit approvals (if applicable).
- The passage of this resolution creates no legal rights, until and unless all agreements are fully executed by the City.
