**CITY PARKADES ELECTRIC VEHICLE CHARGING FEES BYLAW,
AMENDMENT BYLAW (NO. 2)**

A BYLAW OF THE CITY OF VICTORIA

The purpose of this Bylaw is to amend the *City Parkades Electric Vehicle Charging Fees Bylaw* to:

1. Update the fees for direct current fast charging stations to set fees based on amount of power delivered; and
2. allow the City to enforce the City Parkades Electric Vehicle Charging Fees Bylaw where the City has a licence or lease to operate EV charging stations on private property.

Under its statutory powers, including sections 8(3)(b), 62, and 194 of the *Community Charter*, the Council of the Corporation of the City of Victoria in an open meeting assembled enacts the following provisions:

Title

- 1 This Bylaw may be cited as the “City Parkades Electric Vehicle Charging Fees Bylaw, Amendment Bylaw (No. 2)”.

Amendments

- 2 Bylaw No. 20-032, the City Parkades Electric Vehicle Charging Fees Bylaw, is amended in section 2 as follows:
 - (a) in the definition of “surface lot”, by inserting “, or a portion thereof,” immediately after “ground level parking lot”;
 - (b) Schedule A is repealed and replaced with the new Schedule A attached to this Bylaw as Appendix 1.

Commencement

- 3 This Bylaw comes into force on adoption.

Appendix 1

SCHEDULE A Electric Vehicle Charging Station Fees

The fee payable for the use of a charging station in a parkade or on a surface lot is determined by the type of charging station, the specifications of the charging station, and the corresponding user, as detailed below.

Row	Type of Charging Station	Charging Station Specifications	Fee for Drivers	Fee for Monthly Permit Holders
1	Level 1	N/A	\$1.00 per 8 hours of use	N/A
2	Level 2	without power sharing	\$1.00 per hour	N/A
3	Level 2	with power sharing	\$0.25 per hour	\$35.00 per month
4	DCFC	hourly billing - 25 kilowatts	\$5.00 per hour	N/A
5	DCFC	hourly billing - 50 kilowatts	\$12.00 per hour	N/A
6	DCFC	hourly billing - 100 kilowatts	\$16.00 per hour	N/A
7	DCFC	power-based billing	\$0.41 per kilowatt	N/A
