Subject:	2025-2029 Draft Financial Plan – Impact of Province's Decision on Victoria Esquimal Police Board Section 27 Appeal			

RECOMMENDATION

That Council receive this report for information.

EXECUTIVE SUMMARY

Under section 27 of the *Police Act*, the Victoria Esquimalt Police Board appealed Victoria and Esquimalt councils' 2023 police budget approvals. Each council approved slightly different amounts for the disputed line items and, as a result, the lower amounts approved are included in the financial plans of the municipalities. A letter from the Province's Director of Police Services dated January 29, 2025 (Appendix A) outlines their decision that some of the disputed amounts must be added to VicPD's budget.

The impact of this decision to the City of Victoria is as follows:

The 2025 Provisional Police budget request requires a property tax increase of 3.34%. Assuming that the Police Board requests the full amount from this decision, the resulting total property tax increase for police would be 3.72%.
