- Public Notification and Comment
  - · Notice Posted at entrance to establishment
  - · Mailed Notice to within 100m of establishment
  - 30 days to provide comment
- Local Government provides a resolution with comment on:
  - · Potential for Noise
  - · Potential for Impact on the Community

## **Staff Review and Public Comment**

- Impact Assessment
  - The establishment is located below grade and soundproofed, and will have security on-site to proactively prevent noise or disturbance outside the venue
  - The proposed hours allow the establishment to offer venue rentals for a variety of events, and the hours are consistent with other licenced establishments in the area
- Public Comment
  - · Letters were sent to 343 owners and occupants
  - · In response, seven letters were received: five were supportive and two were opposed
  - The Downtown Residents Association confirmed that they support the application given the existing soundproofing and security in place, and the establishment helping to fulfill the city's need for performance venues
