PUBLIC NOTICE

The City of Victoria is seeking your input on a licence application for a cannabis retail store at 3198 Quadra Street.

The Province of British Columbia issues licences for cannabis retail store. The City becomes involved in this process at two stages. First, the City confirms that the property is zoned for cannabis retail use. Second, if the Province determines that an applicant is suitable, Council recommends whether or not the Province should issue a cannabis retail store licence.

The property is zoned for cannabis retail store use.

The applicant has passed a suitability assessment, which is determined by using the following checks:

- criminal record check or finger-print based criminal record verification
- police information check
- check of intelligence databases maintained by law enforcement agencies
- check of records in the justice information system of the BC Ministry of the Attorney General
- check of records in the corrections information system of the BC Ministry of Public Safety and Solicitor General.

Council will make a recommendation about whether or not to support a provincial cannabis retail store licence application. This recommendation consists of the Council's views on the general impact on the community, residents' views, and a recommendation to issue the licence or not. Residents are invited to provide written comments about this application.

Members of the public interested in this matter may provide written submissions to be published on the agenda for consideration at the meeting of Council at which this matter will be considered.
