

At 12 stories this proposal would destroy this effect. To say that this proposal acts as a "counterpoint" to the Belmont Building is a bit of a stretch, a 6 block stretch, that few if any would notice. The space at the corner of Pandora and Government already exists as a public plaza. It doesn't' need to be elaborate given proposed improvements to the already existing Centennial Square across the street, and could be improved upon at minimal taxpayer cost with benches and public art. Many recent residential developments in the downtown (outside of Old Towne) and surrounding neighbourhoods have already exceeded height and density limits contained in the OCP in order to address the current housing crisis. The same argument doesn't apply to the same degree for commercial uses such as hotels. Locating a building of this size and scale in Old Town will detract from its historic ambiance, scale and uniqueness and counter the very reason why Victorians and tourists are attracted to the area.



I am writing to express my strong opposition to the Hampton Inn proposed for 603 Pandora Ave. For the past 17 years I have been a resident of the Vogue condos above MEC at 599 Pandora Avenue. Living directly across from this site, facing Government Street, I have had a unique 24/7 direct view of this space over quite a long period of time. I have experienced, first hand, the various iterations of this space, from when it was the Plaza Hotel/Monty's, the many years where the building just sat vacant and the last almost 5 years since the historic building burnt down leaving a pile of rubble behind the art covered fence. As a long term neighbor to 603 Pandora Ave, I am definitely eager to welcome an exciting new use for this lot. Unfortunately though, I believe that the proposed Hampton Inn project is ill-suited to this particular location as it is egregiously misaligned with the Official City Plan and the vision for preserving and enhancing our Old Town District. The main issue with this project is the extreme height variance requested which, at 38.2 meters, is 250% of the OCP height restriction of 15 meters for the Old Town District. The secondary issue is, as a limited-service hotel, this project only exacerbates our housing crisis by essentially creating a purpose-built, corporate owned airbnb project, created exclusively to house tourists when the lot has previously been approved for, and would much better suit, a desperately needed residential development. This proposal in no way fits within our Official City Plan, and it is not just a little bit outside the OCP Old Town guidelines, it attempts to completely rewrite them. To begin with, most of the Old Town heritage buildings are 2 to 3 storeys, well under the 15 meters height restriction, and new builds are mostly 3-5 storeys, standing around 15 to 18 meters high. The developer of this project is aware of the 15 meter height restriction, as stated in their letter, yet would like approval for 38.2 meters, more than 2.5 times what the area allows. The Old Town guidelines stipulate that new builds should enhance the surrounding character of the neighborhood. In contrast to the human scale and charm of Old Town, the proposed Hampton building is an extremely large, dense, block-mass. The design appears to be quite uninspired and its towering bulkiness feels woefully out of place. Considering this architecture firm has designed some of the most interesting and iconic buildings in Victoria, this design is very disappointing and lackluster. It is just a big, solid, brown, basic budget hotel, exactly like one you could find in any nondescript city, although most often by an airport where the vast available space better suits its immense size requirements. The OCP also requires projects to blend with neighboring buildings and, in order to maintain an attractive, cohesive and proportionate sawtooth roofline, new developments must be within a maximum of a 3 storey height difference to their adjacent buildings. The lot for this development is surrounded on all sides by historic, period heritage buildings of 2 to 3 storeys such as City Hall, the Brackman-Ker Milling Company buildings, McPherson Playhouse, and the Prior Building. The buildings directly adjacent to 603 Pandora Ave are 2 storey on Pandora and 3 storeys on Government, meaning a suitable cohesive development should be only 5 storeys maximum. Because I live here and know the area well, I do not believe the developer's illustrations truly demonstrate to the casual observer just how much this new building plans to tower over all its neighbors. Viewing the 3-dimensional architectural model in person made it quite clear that a 12 storey building next to 2 and 3 storey buildings will have an incredibly dwarfing effect on these star heritage buildings and would fit into the space about as well as a monster truck fits into a small car parking space. A little more than a year ago, this Hampton Inn project was presented as a 6 storey development. Now, due to rising costs, they claim that in order to be viable they must double the size of the project to 12 storeys. The only reason offered for this is the desire for a certain predetermined amount of corporate profits. Ensuring adequate profits for multi million dollar corporations is not a valid reason for an entire city to so dramatically disregard the established OCP restrictions for Old Town. It makes much more sense for the corporation to adjust their business model in a way that a profitable project can be built within the 15 meter height restriction. Some ideas which may allow for profitability within a 15m high project might include raising nightly rates in accordance to inflation and demand, adjusting the room sizes to much more compact micro-suites so that more rooms could fit on each floor, promoting off-season travel to reduce fall and winter vacancies, pivoting to a luxury boutique hotel brand with a higher nightly rate, or considering a residential rental or strata building. The recently approved Duck Building Hyatt, Shotbolt project and Northern Junk residences have all managed to find a way to create an expectation of profit within or very close to the 15 meter height restriction while facing the same rising costs that Hampton Inn claims makes their project untenable. If a 15 meter tall Hampton Inn simply cannot be profitable then this is clearly just not the right space for this particular project. This project's blatant disregard and, frankly, disrespect for the Old Town District and its guidelines, charm, heritage and character is shocking and truly shows a lack of understanding of the essence of the very district of which it wishes to benefit from. Rather than enhance the area, this building would become the dominant force by eclipsing all the surrounding low rise heritage buildings. It is illogical to suggest we drastically alter our Official City Plan on the grounds of increasing the profit of a multi-million dollar corporation. It is much more reasonable for the corporation to adjust either their business model or their location to one that is more suitable for their predetermined profitability requirements which dictate a project which so grossly falls outside the Old Town plan and vision.
