In addition, the City of Victoria should have records of my homeowners grant application and approval from when I paid my property tax last year. Unfortunately, I do not have confirmation of this. When I started to rent my principal residence as a short term rental, I called my insurance agent and advised that I now required coverage that would ALSO cover my short term rental activities. The documents previously sent were the coverage I was sold. On my next renewal, I will investigate why they do not also indicate that this is my principal residence. However, I am currently settling a claim related to the recent flood damage and cannot discuss a change in coverage with them at this exact time. I would like to note that all of this documentation was offered to the inspectors when they attended my condo. I have been forced to rent my principal residence part time due to a medical condition that has made it so that I am unable to work. The short term rental income allows me to continue to afford my home. This situation has not changed in any way since my licence was approved in May 2024. I have always, and will continue to always, operate as required by the regulations. I would never risk the loss of this very important income by contravening any regulation. The stress caused by difficulties in trying to prove that my one and only home is in fact my home, and the potential financial implications of not being able to do so, have exasperated my health condition. As someone who has done nothing but follow every rule and jump through every hoop presented, it is frustrating that this feels like such an adversarial process.

I appreciate your time and hope that you will find the above documentation sufficient to prove that 402-960 Yates Street is my principal residence. If there is any other documentation I can provide, please do not hesitate to let me know. I will be away from town for the next while attending to my father who is having surgery soon. Therefore, I would appreciate if any further correspondence could be done by email or phone . Sincerely, Tanya Dodd


