Letter to Mayor and Council November 8, 2018 Public Hearing

The Committee of the Whole meeting of September 17, 2017 requested that the applicant was directed by council to:

- Revise the cladding and other exterior details of the buildings
- Retain the trees on the Pendergast Street frontage of the property

Actions taken by the applicant:

- The metal cladding was removed and replaced with Hardiboard shingles.
- The arborist report stated that the elm tree (on Pendergast Street) located on the south-east corner could not be saved because several of the major support roots would be severed during excavation which would compromise the structural integrity of the tree.
- The maple tree located on the south side of the property (Pendergast Street) will be retained.
