


# Small Lot Rezoning Petition

He reiterated his support at the James Bay Community Association Meeting in March. However, he has not returned his signed petition and for that reason we have had to consider him neutral.
  - We did not receive the petition from the neighbour at 232 Superior until May 26 so it was not included in the original submission. It is attached here.


