# **RECREATION FEES BYLAW, AMENDMENT BYLAW (NO. 10)**

### A BYLAW OF THE CITY OF VICTORIA

The purpose of this Bylaw is to add the Park Furnishing Dedication Program fee schedule and update the title of the *Recreation Fees Bylaw, No. 06-056*.

Under its statutory powers, including sections 8 and 194 of the *Community Charter*, the Council of The Corporation of the City of Victoria in an open meeting assembled enacts the following provisions:

### Title

1 This Bylaw may be cited as the "Recreation Fees Bylaw, Amendment Bylaw (No. 10)".

#### **Amendments**

- 2 The Recreation Fees Bylaw, No. 06-056 is amended:
  - under the section entitled "Contents", by adding "Schedule I Park Furnishings Dedication Program Fees" immediately after "Schedule H Filming Fees";
  - (b) in section 2, by adding the following definition immediately after the definition of "non-spectator event":
    - "Park Furnishing Dedication Program" means a program established by the City to allow citizens to dedicate a park furnishing in City parks or public places to honour the memory of a person or event;";
  - (c) by repealing section 3(1) and replacing it with the following:
    - "A person who enters a City recreation facility, sports field, or park, uses City equipment, supplies, or festival equipment, films in or on City property, or participates in the Park Furnishing Dedication Program, must pay the applicable fees and comply with the regulations set out in Schedule A to I attached to this Bylaw.";
  - (d) by adding Schedule I contained in Appendix A of this Bylaw immediately following Schedule H; and
  - (e) by changing the title of the *Recreation Fees Bylaw, No. 06-056* to "*Parks and Recreation Fees Bylaw, No. 06-056*".

# Schedule I

# **Park Furnishing Dedication Program**

# (Subject to applicable taxes)

Item	Furnishing Capital Cost	10 Year Maintenance Contingency	Administration Fee	Total Cost of Dedication
Park bench	\$ 2,600	\$ 650	\$ 250	\$ 3,500

- 1. All dedications are subject to a 10 year term, and availability as determined by the City's Parks, Recreation and Facilities department.
- 2. The fee for a renewal term shall be equal to the fee of the same or equivalent item shown in the above table.
- 3. The Park Furnishing Dedication Program may include park benches, picnic tables, drinking fountains, games tables, or other furnishings designated by the City's Assistant Director of Parks, Recreation and Facilities.
- 4. The City shall apply the following formula to determine the donation fee for a park furnishing:

Furnishings Capital Cost (purchase, fabrication, + bronze plaque, and installation)	O year Maintenance Contingency (25% of Amenity Capital Cost)	Administration Fee (\$250)	=	Total Cost of Dedication
