Having visited the Drake many times, noisy, rowdy or disorderly conduct seem alien to the site (as well as many others in the area, such as Swan's, Canoe, the Guild (recently closed), Little Jumbo, and Northern Quarter.

It has need for businesses that attract and engage locals, other Victorians and tourists, especially when those businesses are managed with pride, quality and policed exceedingly well. I am sure this new venue will be just such an establishment. So, I encourage you to support and approve this venture.

Dear Mayor and Council,

I have lived on the corner of Herald and Government Street for 27 years. I am delighted to see my neighbourhood become more vibrant. However, the Herald Street BrewPub should be reviewed with caution.

This is the same street in which previous liquor applications have been refused or limited; a marijuana dispensary was not allowed; that has the Chinatown Care Home (directly across from me); and new residential density with the Ironworks and the inevitable lower Chinatown developments.

I must say, as much as I like the existing neighbourhood lounge Phillips, two blocks north on Government Street, it has already created more noise issues for us nearby residents.

I'm afraid the much closer Herald Street Brewpub will only amplify this problem. As such, its hours should be limited to midnight as originally put forward, with a capacity of 100. Furthermore, my understanding is that the public area is partially outdoors (rooftop). This will create more noise issues and is another reason hours should be limited. Afterall, any city or non-profit special events that happen in Chinatown or in nearby Centennial Square have much earlier noise restrictions.

I have really enjoyed watching my city become more vibrant in the last few years. It is a pleasure to see people out in the streets after 8pm, enjoying cafes restaurants and pubs. It is reminiscent of other vibrant cities I have visited in the past, and I think that it makes a city more interesting and safer to have more businesses and people in the downtown core.

I have admired the Drake Eatery on Pandora St and have been going there with family and friends for years.
