- December 2, 2016, Officer Ferris attended 2641 Quadra, cannabis business was in operation, two employees stated owner had submitted business licence application, but had not yet submitted a re-zoning application. No other issues.
- December 8, 2016 the City received a business licence application for a Storefront Cannabis Retail licence at 2641 Quadra Street from Sidney Smokehouse Inc., BC0526109 Ltd, director listed as Mary Anne Emmott, address of 201-7851 East Saanich Road.
- March 8, 2017, Officer Cockle attended business and noted only one issue with regards to logo above their name on front signage and stated she would follow up.
- March 26, 2017, Officer Cockle attended business and informed Mary Anne Emmott that the sign was not in compliance (Bylaw 19-053) and needed to be removed.
- April 12, 2017, Officer Dolan attended to conduct inspection and noted edibles were on display but on sale as they were being cleared out.

- July 4, 2019, Officer Dolan attended business at 1026 hrs and business was closed, with a sign posted "closed until we receive provincial licence". (no exact date operation closed)
- August 21, 2019, Officer Dolan attended and confirmed business remains closed.
- August 25, 2019, Officer Dolan attended and business remains closed.
- September 29, 2019, Officer Dolan attended and business remains closed.

Business license fees were paid in the amount of \$5000.00 on Dec 9, 2016, Jan 13, 2017, and January 24, 2018. No further issues with the operator and no formal complaints were received.
