## A BY-LAW

to designate certain buildings on Government Street as Heritage Structures.

WHEREAS it is provided by Section 714A of the Municipal Act that the Council may by by-law subject to the approval of the Lieutenant-Governor in Council designate any buildings, structures or lands in whole or in part as heritage buildings, structures or lands for the purpose of preserving evidences of the Municipality's history, culture and heritage for the education and enjoyment of present and future generations;

AND WHEREAS the Council, having regard to the need for preserving heritage buildings, structures or lands which collectively represent a cross section of all periods and styles in the City's historic and cultural evolution, the costs and benefits of the preservation, and the compatibility of preservation with other lawful uses of the buildings, structures or lands, has deemed it expedient to designate certain buildings and parts of buildings along Government Street as heritage buildings;

AND WHEREAS those affected by this by-law have been given an opportunity to be heard by Council;

AND WHEREAS the Lieutenant-Governor in Council has approved of this by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of Victoria enacts as follows:

- 1. This by-law may be cited as the "Heritage Designation By-law (No.8) 1975".
- 2. Those buildings or parts of buildings shown on Schedule "A" hereto, situate on the lands mentioned in Schedule "B" hereto, are, to the extent shown on

the map on Schedule "A", designated as heritage buildings for the purpose and within the meaning assigned thereto in Section 714A of the Municipal Act, that is to say those buildings covered with oblique lines are designated in whole and those buildings with solid lines are designated only in respect of the exteriors represented by such solid lines, as will more fully appear on reference to the key on the map.

The provisions of this by-law do not apply to the interior of any building.

Passed by the Municipal Council the 10th day of July A.D. 1975.

Approved by the Lieutenant-Governor in Council the 14th day of November A.D. 1975.


