To whom it may concern;

We wish to express our vigorous opposition to the Provincial License Application for a Cannabis retail store at 475 Gorge Road East, Victoria, BC as described in City of Victoria letter dated October 11, 2019.

Regardless of present zoning, we consider that this mixed use residential neighbourhood risks having more cannabis retail stores than is required. We oppose a concentration of retail stores focussing on cannabis products. The neighbourhood would be better served with mixed retail stores offering a wider variety of non-cannabis products, goods and services to the community.

If the City is unsuccessful in limiting the Provincial License Application we ask that any new cannabis retail store license be only awarded conditionally with a clear understanding that a comprehensive review of neighbourhood social impacts be assessed within a year. Enforcement of access to cannabis products by the many minors living and playing in the immediate neighbourhood, any changes to pedestrian and vehicular traffic (eg. parking), effects on the existing businesses and general changes will require assessment. The Tim Horton's across the street voluntarily shortened it's hours of business in May 2017 in response to neighbourhood and law enforcement pressure to avoid risk to citizens and property.

The current established residential uses adjacent to 475 Gorge Road East must be respected by the Province and the City in view of the urgent need for more, not less family friendly housing in the City of Victoria.

I appreciate the opportunity to submit my comments regarding the provincial license application for a cannabis retail store at 475 Gorge Road E.

I live in a condo one block away from 475 Gorge Road E., and strongly object to yet another social burden placed in a neighbourhood struggling with some of the most serious social ills and challenges.

The Burnside/Gorge neighbourhood is already stressed with family homelessness and inadequate housing, poverty, crime, and drug overdose. On my street is a half-way house run by the John Howard society; within a few blocks there is Rock Bay Landing on Ellice Street. There is a growing presence of homeless people in our neighbourhood, and an alarming increase in drug addicts and crime. The last thing we need is a magnet for more addicts, drawn to our neighbourhood by a cannabis outlet, with attendant opportunities to find other drugs.

There are families with young children living in my building. The children like to play on the lawn, and I see them making chalk drawings on the paths, or playing with their small dog. They should be able to do these things without finding drug paraphernalia left by addicts, or excrement left by homeless people who try to camp out on the green spaces around our building.

In an effort to try to stop trespassing people from engaging in prostitution, taking drugs, or camping out on our property, we have spent tens of thousands of dollars installing a tall metal fence. We have spent further thousands upgrading our security with cameras at the entrances to our building. Addicts are entering our building and stealing whatever they can to fund their drug habits Residents in my building can attest to finding thieves in our building; the Victoria Police Department can verify that this is happening on an ongoing basis.

What possible social benefit could accrue from placing a recreational drug dispensary in a neighbourhood already struggling with some of our most difficult social challenges? We all need to share the responsibility of solving our collective problems, and we all need to share what that means on the ground. What it does not mean is putting yet another social negative in the same overburdened neighbourhood.

People who makes decisions regarding other people's neighbourhoods need to stop and consider fairness. Why is our neighbourhood, already disproportionately burdened as it is with the challenges of poverty, drug abuse, food and housing insecurity, crime, and homelessness, asked to accommodate a business of dubious benefit to those of us who live here? Why not place such a business in Oak Bay Village, Estevan Village, Cook Street Village, or in Fernwood? Possibly these are the neighbourhoods the decision makers return to in the evening. Residents of Burnside/Gorge would like other neighbourhoods to share some of the burden.

Please seriously consider my letter, and deny the application.
