- October 26, 2016, received Business licence application from Rosetta Duncan, sole proprietor, business name “Burnside Dispensary”
- January 10, 2017, Inspection by Officer Murphy, & Licence Inspector Ferris, owner given 14 days to remove a sign posted on corner of Harriet & Burnside., and a requirement to remove a “cross” on an interior sign.
- January 24, 2017, “cross” removed from large sign at corner of Harriet and Burnside road.
- February 27, 2017, Officer Murphy & Officer Cockle completed inspection, were told to remove image on window sign, remove sign on corner of Harriet and Burnside.
- April 2, 2017, Officer Murphy working with owner with regards to signage.
- August 16, 2017, Officer Murphy completed inspection, no issues.
- September 27, 2017 Officer Murphy completed inspection, no issues.
- October 22, 2017 Officer Murphy completed inspection, no issues.
- December 3, 2017, Officer Murphy completed inspection, further signage issues that owner is working through.

- October 23, 2018 Officer Murphy attended business to note new signage on property in compliance.
- October 26, 2018 Name change from Burnside Dispensary to Burnside Buds. BC1070968 director Rosetta Duncan.
- November 7, 2018, Received citizen complaint that business was still in operation.
- April 2, 2019, Officer Murphy inspection shows business is still in operation.

- August 25, 2019, Officer Murphy inspection showed business no longer operating. (cannot confirm what exact date the retailer stopped operating)
