The applicant The Union Club of British Columbia is applying for a Patron Participation Entertainment Endorsement for their food primary license number 109341 to enable patrons to dance in the food primary licensed area of the establishment.

The nature of the establishment is such that there should be no noise impact on the community and the establishment will not operate the food primary licensed area contrary to its primary purpose as a food primary licensed area.

The patron participation entertainment will end at 12 Midnight as stated by the Liquor & Cannabis Regulation Branch.

The Union Club of British Columbia has a positive record with the Liquor & Cannabis Regulation Branch, the City of Victoria and the Victoria Police Department.

Having a patron participation entertainment endorsement offers an added amenity for patrons. The applicant also submits the following additional factors for consideration:

 The Club has consistently attracted a diverse and impressive membership which has been at the heart of the business, political and cultural life of Victoria from its early colonial beginnings.

- This patron participation entertainment endorsement would add greater flexibility to this venue.
- This establishment is not operated as a pub or neighbourhood house.
- The experience is that venues such as the Union Club of British Columbia tend not to create problems in the community.
