Thank you for seeking input on the proposed changes to 1109/1115 Johnson Street,1100/1102/1108 and 1120 Yates Street and 1309/1315 Cook Street.

Our orthodontic office, on the fifth floor of the 1120 Yates Street building, has been in this location for almost 30 years. Parking has never been a big problem until recently. Our staff parking is already substantially decreased and if I am reading the proposal correctly the promised 120 parking spots for the Victoria Professional Building will be reduced to 0.

As well, there will be a shortage of an additional 95 spots in the proposed 12 storey and 6 storey buildings.

This could mean that we will not have 100 spots reserved for our building in the new underground parkade proposed for the 12 storey building that was part of the agreement when we renewed our lease.

In addition, our patients would have great difficulty in finding on street parking due to the higher demand caused by the substantially reduced availably in the proposal.

As a specialists' office, we have many patients who live far away and it would be difficult to expect them to rely solely on public transportation.

If the proposed changes are granted ,a new location would need to found for my office to be able to satisfy our patient's needs.

Please accept this letter as a testament of my support of Chard Development's application to develop property at Cook and Yates. Having been proactively engaged by Chard to act as their agent in securing a provider to lease and operate the purpose-built childcare facility within their proposed development, I am able to as a commercial realtor (but also mom of three young children) attest to the need for developments such as these.

The space that will be dedicated for childcare use, on the second floor of the 12 storey building, includes over 7,500SF of interior space and an outdoor terrace of over 1,100SF. Chard's commitment to a ten-year covenant will secure the space exclusively for childcare use into the future. The design of the space features an abundance of natural light, high ceilings, and a sheltered ground level entrance with elevator. In my opinion it is well suited to the intended childcare use.

At Chard's direction our initial RFP was issued to local not-for-profit childcare providers, with preference given to such organizations. More than a dozen organizations have been contacted to date; a few have expressed serious interest in exploring this opportunity further and work is currently underway to secure an LOI with one operator in particular (which can be challenging so far in advance of occupancy).

As the amount of interest shown to date by potential childcare operators suggests, there is a great need for childcare within Victoria, with approximately one space available for every eight children under age 3 amongst existing licensed operators. The inclusion of childcare amenities into developments such as Chard's benefits families within the neighborhood by providing safe, new, purpose-built facilities in convenient locations.

I sincerely hope that Council will see fit to approve this application, thereby facilitating the supply of approximately 50 new childcare spaces to Fernwood and the community beyond.
