I have submitted an application to the city and the LDB to increase the liquor service hours on my Liquor Primary License from 11am-1am Monday to Saturday, 11am-midnight Sunday and have them extended to 9am-1am Monday through Sunday.

I am making this application due to the fact that we'd like to have the ability to offer our guests the option of having beverage service earlier in the day, as we receive many requests for things like Caesars and Mimosas before 11am especially during the summer months when we see a lot of tourist traffic in the hotel; broadening our hours of beverage service will allow us to do more business with those guests. Also, as our restaurant operates within a hotel, we often see guests checking in late-night and it would be beneficial to our business to be able to offer beverage service until 1am every day.

The service area of our Liquor Primary License only encompasses our Lounge area indoors, so we can rest assured that this extension will not affect our residential neighbours by allowing service until the hour of 1am on our outside patio.

This application has been submitted with the intention of increasing our business levels and appealing to a wider demographic that includes both local and transient guests. It will enable our restaurant to remain competitive within our local set of restaurants and will, I hope, help to grow our business. 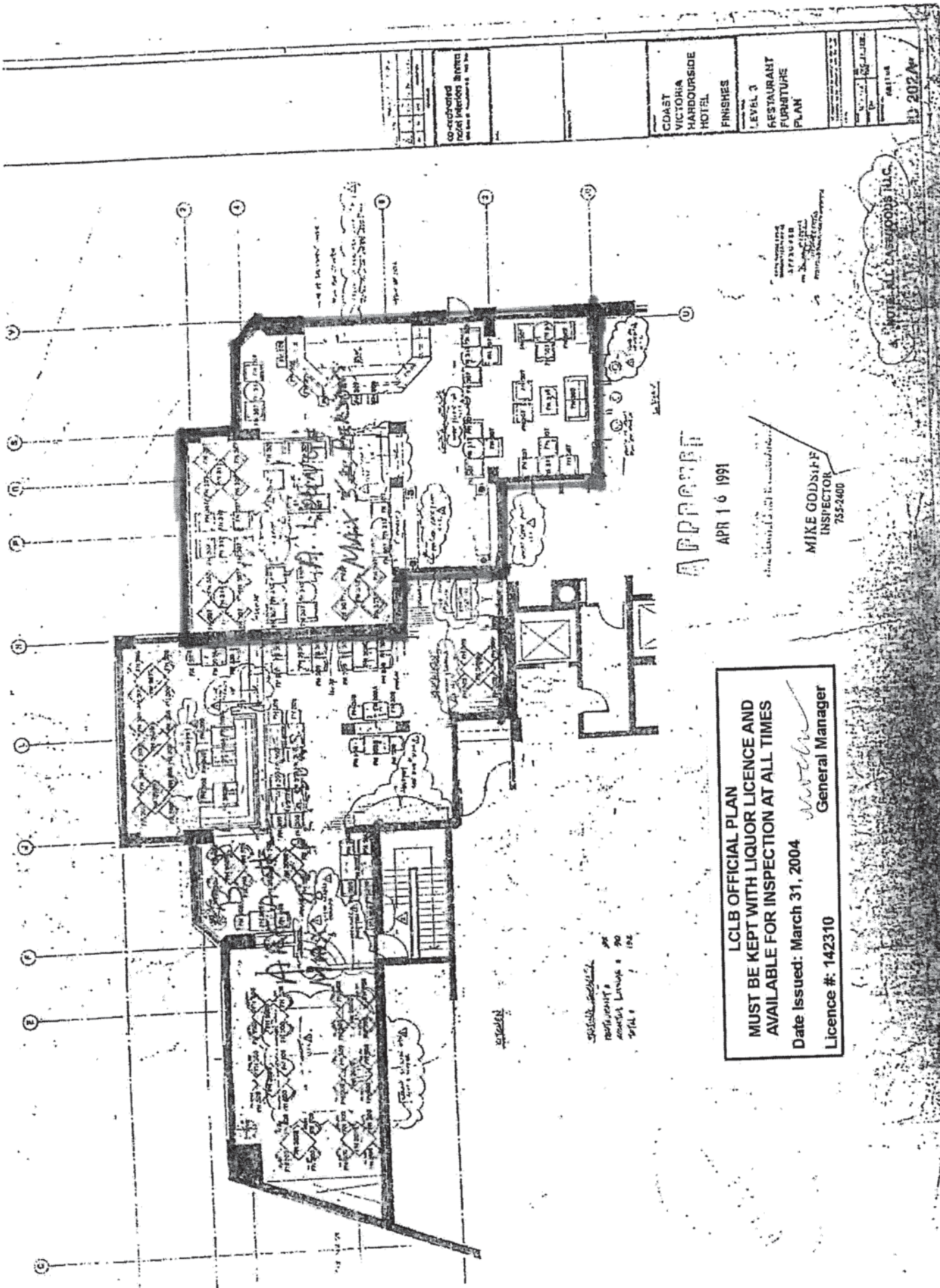
