We're opposed to the issuance of a license to serve liquor at 777 Douglas Street. Bars privatize the profit from the sale of liquor and socialize the costs to the community in the form of drunk and disorderly conduct, public urination and vomiting, noise, and malicious destruction of property. Please find attached the letter that came to us from the City of Victoria. We live within 100 metres of Bartholomew's Pub, so the City has to ask for our input before they allow a change in a liquor license. Our concern is that there is a lot of noise and yelling on Friday and Saturday nights. If we open our window it is hard to go to sleep because of the noise even on the 10th floor of our condo; if we close the window, it is sweltering on warm nights. A closing time of midnight is late, but 1:00 am makes it very difficult to go to sleep as the Pub is across the street on our South side. We strongly object to extending the hours for Bartholomew's Pub.

On the other side of our condo building (The Falls), The Strathcona serves liquor and the noise to the North side of our condo building is so bad that many of the condos directly across on lower floors have been converted to AirBnB rentals. The Falls owns one condo directly across from the Strathcona, which they assigned to our building manager. He and his wife couldn't stand the noise so they were reassigned to the South Tower. Now the condo across from the Strathcona is rented to a woman who only stays there on Monday morning to Friday afternoon and goes home on the weekends somewhere outside of Victoria. I would hate to see the noise level continue to increase for our South Tower.

We also think it is not good to start serving liquor at 9 am, as there is an outdoor pool table near Bartholomew's Pub entrance and lots of pedestrians and kids walk down Humboldt Street. Why is it necessary for anyone to start drinking at 9am? Also, the patrons from The Strathcona take smoking breaks throughout the day on the sidewalk that we must use to reach the downtown. I assume the Bartholomew's Pub patrons will do the same. The City of Victoria allowed massive development of condos in the downtown. Surely they must have realized that late night noise and yelling along with smoking outside the Pubs was not compatible with residential living.

Dear Mayor Helps and Council,

Members of the DRA LUC met with the applicant's representative, Bert Hick, on 22 January 2020 to discuss the new liquor primary application for 777 Douglas Street. From this meeting and correspondence from the City we understand the following:

- While the application is for a new standalone liquor primary license, it is for a 46-person capacity area that is already approved by the Liquor Branch on the existing Bartholomew's liquor primary license.
- This application seeks to separate the capacity of 46 onto its own liquor primary license.
- The new liquor primary license will be for the same capacity of 46 persons and will be known as "The Humboldt".
- The 46-person capacity will be deleted from the Bartholomew's license through a structural change application to the Liquor Branch, which was sent in for processing to the Liquor Branch with the application for the new liquor primary license.
- There will be no increase of liquor primary seats at the hotel.
- The new license for The Humboldt will have the same hours as the existing license –
 9am to 1 am 7 days a week.

DRA LUC members have reviewed the application, do not have any concerns, and support the application as presented.
