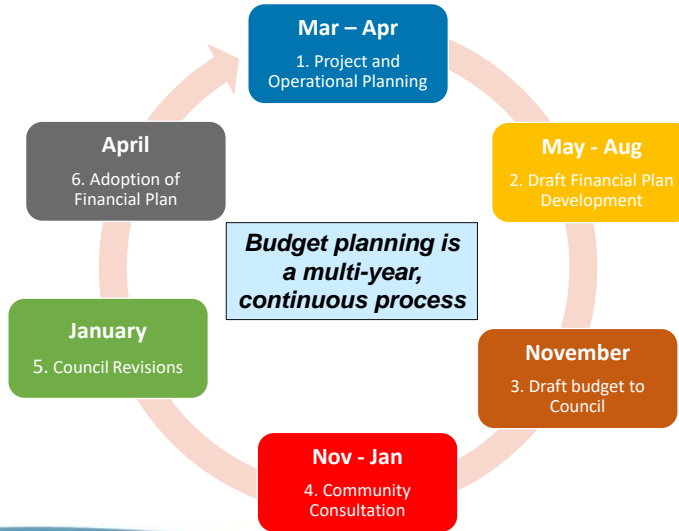

## Context for 2021

Due to COVID-19 pandemic:

- Significant revenue shortfalls
  - Parking
  - Victoria Conference Centre
  - Leases for City-owned Property
  - Business Licences
  - Arena Ticket Surcharge
- Additional costs
- Closures of some facilities
- Period 2 Accountability Report – many initiatives will be carried forward to 2021

## Council Direction

- Standing direction:
  - Continued provision of services at current service levels
  - Maximum tax increase of inflation plus 1% (2019-2022 Strategic Plan)
- A number of mitigation strategies approved for 2020 budget

Average inflation  
for 2020 is 0.75%



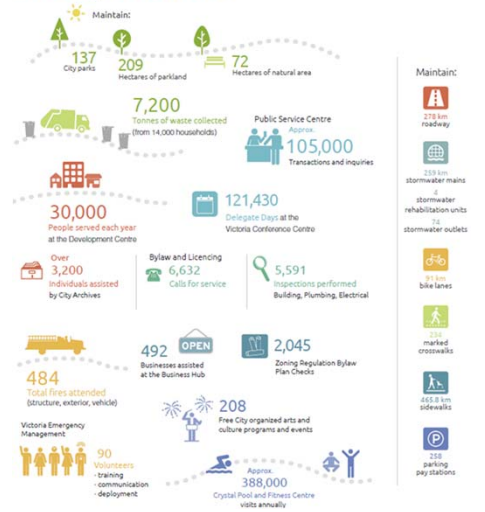
