A B Y - L A W

To designate certain buildings on
Wharf Street as heritage buildings

WHEREAS the Council, with due regard to the considerations mentioned in Section 714A (3) of the Municipal Act, deems it expedient to designate certain buildings on Wharf Street, Victoria, as heritage buildings for the purpose of preserving evidences of the history of the City of Victoria's culture and heritage for the education and enjoyment of present and future generations;

AND WHEREAS the Lieutenant-Governor in Council has approved of this by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of Victoria enacts as follows:

1. This by-law may be cited as the "Heritage Designation By-law (No. 6), 1974".
2. Such of the buildings as are shaded black on the map appearing on Schedule A to this by-law and situated on the lands described in Schedule B are hereby designated as heritage buildings for the purposes stated in Section 714A (1) of the Municipal Act.
3. By-law Number 6624, cited as the "Heritage Designation By-law (No. 1), 1974", is hereby repealed.

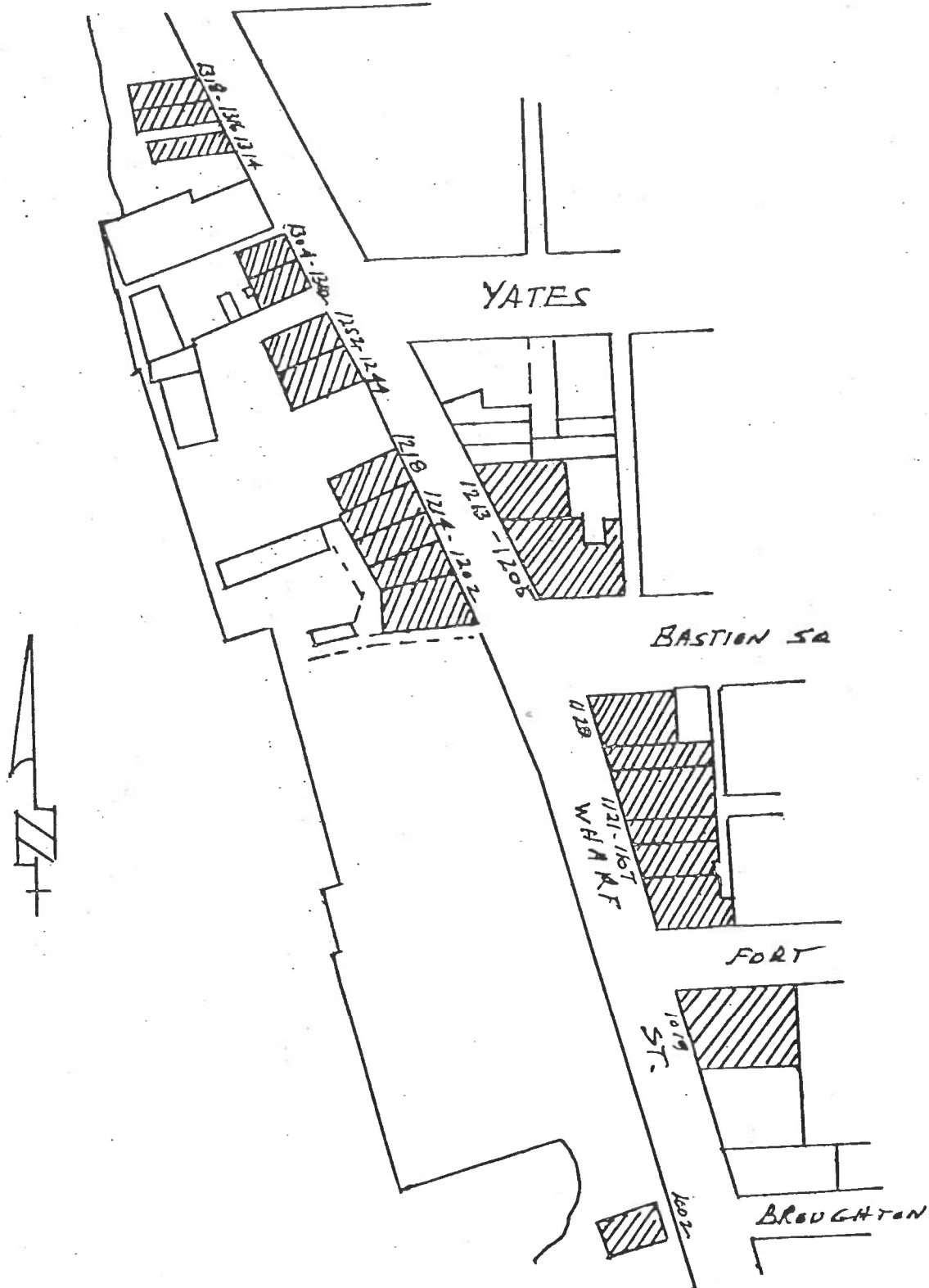
