The application from the Bedford/Churchill is for an increase to the capacity from 90 to 144 (and corresponding floor plan change/expansion). Although this is a significant increase to the number of seats, the impacts to the immediate neighbourhood are minimal. There are no residential units within the immediate vicinity. The hotel units that could be affected are operated by the same applicant/owner/operator. So they can manage the potential impacts to their own clients.

The only issue here is the ever-present incremental impacts of increasing liquor seat capacity and density in the downtown core. There is only one City Department on duty in the late evening hours with the duty to respond to a deal with liquor related disorder — it's the Police Department. Late Night funding (which we rely heavily on) is in question, and the Department's ability to adopt additional pressures and calls for service in the late night hours are already at capacity.
