To whom it may concern,

I am writing about the proposed variance to the fence bylaw for the property at 545 Manchester Road.

I live in the townhouses at 3015 Jutland Road, with my unit facing onto Manchester directly across from this property. I do not see an issue with this variance, for reasons that I will explain below. The only thing that I would suggest would be landscaping buffer be included to soften the look of any fencing that is added. This road is a nice green corridor with many trees and a lot of landscaping on both sides. It would be a shame to reduce that.

For context of those not living in the area, Manchester is a high foot traffic path from the corner of Burnside and Jutland through to Gorge Road. During the week, this is a lot of commuting. But a decent amount of this foot traffic includes the transient population of the area. I do not say this to insult anyone in that situation, but to offer context. There is a fair amount of yelling and odd behaviour that happens along this road. It happens at least once a week but quite often more frequently, and usually at night.

A fence like this would help the residents feel a little more comfortable in their own yard, and it would also reduce some of the noise that they experience from the instances described above.
