

#308343 - Whistle Buoy Brewing Company Lounge Endorsement Request for Structural Change to Liquor Primary License as Part of the Manufacturing License:

Jan 21st, 2021

To whom it may concern:

Whistle Buoy Brewing Company is located at 560 Johnson St, within the main inner courtyard of Market Square. Market Square is a privately-owned commercial development in the heart of the downtown, old town district. Whistle Buoy is situated in the North East corner of the inner lower courtyard, on a dead-end no through route, which is not located on a municipal street (See Site plan 1 and 2).

Whistle Buoy Brewing Company Ltd. Currently possess a manufacturing license and lounge endorsement license allowing for a taproom and patio area.

(See original approved red line plan – June 2019".

Whistle Buoy Brewing Company Ltd. Is proposing three new aspects of permanent structural change to their Existing License:

1. Expansion of Taproom Area into unit 65-560 Johnson St – The adjacent unit to the south of Whistle Buoy's current taproom:

Whistle Buoy would like to propose their new expansion into unit 65-560 Johnson St, this is the formal takeover of the Sothern adjacent unit, which previously operated as North 48 Bicycles (See Store Directory). The expansion will consist of extending the taproom into the adjacent unit (unit 65) which is a total of 616 Sq. Ft. The occupancy of the new space, by adding the additional two washrooms and floor space will allow for an additional 18 Patrons on the taproom floor. Meaning our total taproom occupancy will be:

Seating Area: 69 Taproom Staff: 5 Total Occupancy: 74

2. Permanent Expansion of Patio Area:

Whistle Buoy would like to propose expanding their patio area permanently from the original size of 720 Sq. Ft., by an additional 690 Sq. Ft., for a total new proposed permanent patio size of 1,410 Sq. Ft. This increased floor space will allow for an additional 36 Patrons on the Patio, meaning our total patio occupancy will be:

Total Seating area: 93

3. Permanent Structural Transiting Corridor Between Taproom and Patio (transiting only, not area for consumption):

Whistle Buoy has now been part of the downtown business community operating as a brewery and hospitality company with no incidents since June 2019. We have partnered with individuals, groups and business in a collaborative manner which has served the greater Victoria community.

Considering all these factors we believe there is a reasonable argument for approving this application and Increasing the size of our taproom and patio to allow for a total occupancy:

Taproom Seating Area: 69 Patio Seating Area: 93

Total Occupancy: 167










Existing Approved Seating Area






