Alignment with VHRF Guidelines

- Affordable rental housing for seniors with median incomes.
- Proposed rents are below median income threshold.
- Project located in Victoria.
- Mix of unit types (Studio, 1 bdrm, 2 bdrm).
- All units designed to basic adaptable housing standards with barrier-free access to all suites and amenity areas.
- Project does not receive further support from the City of Victoria.

Legal Agreements

- Applicant has agreed to enter into a Housing Agreement with the City to secure:
 - > 78 units of rental housing in perpetuity for seniors with median incomes.
 - ➤ mix of unit types including (36) studio, (40) one-bedroom, and (2) two-bedroom units.
- Project will require a Grant Funding Agreement to secure:
 - > eligible use of the grant
 - > obligations to repay if conditions are not met; and
 - > reporting and communication requirements.

VHRF Current Balance: \$3,868,799
1419 Mallek Request: -\$305,000
Potential Balance: \$3,563,799

- Current balance includes \$705,000 allocated for affordable seniors housing.
- Potential balance would include \$400,000 for seniors housing and \$3,163,799 for other VHRF applications received through future intake processes.
