1. Primary Focus

The primary focus of business at VIM is marina moorage, marina club space rental, and captain and crew facilities.

2. Hours of Operations

Operating hours are typically 9am to 5pm 7 days a week; However, the application will be from 9am-10pm Sunday to Thursday and 9am-11pm Friday and Saturday as there are functions that are held in the marina building at varying hours.

3. Entertainment

Types of entertainment will vary pending type of function being held. We will allow for live music, dance floor, DJ booth and TV. There will be no gambling, exotic dancing or anything of that type.

4. Food Service

Full food service is not something VIM will offer. If there are private functions, outside catering will be hired; however, VIM will provide hot and cold snacks as well as non-alcoholic beverages during hours of operation.

5. Neighbourhood

The surrounding neighbourhood is a mix of retail and residential. We are a stand along building, our development has another stand alone building which is a restaurant. Across the street is a residential building.

6. Noise

Noise will be limited as VIM has engineered soundproofing in the building it self and does not have outdoor sitting areas. VIM will also remind guests to keep noise to a minimum when entering and exiting the building.

7. Measures implemented

The measures VIM will implement to assure noise is kept to a minimum for nearby residents are to keep music to reasonable volume as the night goes on, remind guests verbally and with signage.


8. Additional License/ Endorsements






1 Cooperage Place - Liquor License Plan
