### Introduction



- The objective of Phase 1 of the City of Victoria Governance Review is to define the scope of the Governance Review.
- Feedback through consultation with Council, Senior Administration and representatives of external stakeholders may inform scope refinements.
  - MNP will conduct a focus group(s) with representatives of external stakeholder groups.
- MNP has developed selection criteria for Council consideration
- The ultimate goal of discussion today is
  - 1. Council approval of public stakeholder group selection criteria, and
  - 2. Council decision on whether it wishes to delegate selection of the participants to MNP

### Recommended Public Stakeholder Focus Group **MNP** Selection Criteria

#### Stakeholder Criteria

- Understanding and experience with City governance processes
  - E.g., Groups that appear before Council more than once a year (or at least once a year on a recurring basis) as delegates, for their applications, on other topics by Request to Address Council, etc.
  - E.g. Groups with representation on Council Advisory Committees
- Highly impacted by identified governance review and strategic plan topics
  - E.g. Groups that may be impacted by regular or upcoming policy decisions
- Demographic that experiences challenges with access to Council processes
  - E.g., Groups that represent youth, seniors, Newcomers, Indigenous people, accessibility barriers, are economically or socially vulnerable, etc.
- Representative of the diversity of City of Victoria population
  - E.g., Ethnic origin and race, age, gender, education / income, neighbourhood / community
- Current or future relationships with the City
- Close connection / ability to influence resident participation in Phase 2 public engagement opportunities

Aligned with the Council Endorsed Equity Seeking Groups

### **Recommendation to Council**



- Approve public stakeholder group selection criteria, and
- Formally delegate selection of the focus group participants to MNP.
  - MNP is working with City staff to identify stakeholders in each category to participate in the focus groups, including Council Endorsed Equity-Seeking Groups.
