Hi Ryan,

I've reviewed this application and I am concerned with the number of restaurants seeking to extend their hours to 2am. It seems that there is a trend that, if not checked early, the city could end up with significant late night liquor related problems. Before this and the other food primary licences seeking to extend hours are approved, we need to get the "big picture" of how this will impact the community and the police department. The late night problems have grown since the COVID restrictions have lifted and the students have not yet returned. Generally once university and collage students return in the fall, the issues at the liquor establishments amplify.

I think that we need to tally up the number of liquor seats in the city, separating out the midnight closures from the 2am closures to ensure that we have a good understanding of the impact on the city and the police department. As it stands right now the LNTF is deploying with half the staffing of past years due to budget shortfalls. This task force is insufficient with the current liquor related issues.

Until we have had time to look at this from a larger perspective I do not recommend approving this application.
