Good afternoon.

The attached application to LCRB is for Victoria Regent Hotel's new liquor primary licence, which is intended to replace their existing Food Primary licence. The Liquor Primary licence application proposes hours of operation from 12:00 am to 12:00 pm daily with no defined occupant load and allows the hotel to provide room service. The application, letter of intent, floor plan and site plan are attached for your review.

Typically, the sale of alcohol in a rooms minibar is permitted under a hotels food or liquor primary licence associated with other service provided in the hotel. The Victoria Regent Hotel is ceasing food operations and will no longer have a food primary licence as an umbrella licence to cover the minibar sales and they also do not have any service areas associated with an existing liquor primary licence.

For those reasons, they have to apply for a new liquor primary with no occupant load and 24 hour of service daily.

I hope that helps understand the application, and please let me know if you have any further questions.

Please review and submit your comments by August 27th.

- The impact on the community if the application is approved


