## Background

- On March 4, 2021, the launch of the Rent Bank pilot program was reported to Council.
- Council passed a motion that included the following:
  - **2. b. Report back on an as-needed basis if rent bank funding requests arise**
- CSPP is now requesting \$110,000 to continue the project (this includes \$70,000 for the loan program and \$40,000 to support the grant program).

## Overview

Program feature	Disbursed since February 2021	CoV request for 2022
<b>Loans provided through the Rent Bank</b>	~\$80,000	\$70,000
<b>Grants provided through the Housing Security Emergency Fund</b>	~\$349,000	\$40,000

## Pilot Phase Summary

### 2021 Rent Bank Pilot Insights on Applicants



34% were households with children



Spending on average 71% of income on housing



46% were living in City of Victoria

- Half of renters in core housing need
- COVID-19 amplified challenges for renters
- Pandemic reinforces urgency of affordable housing as well as stop gap measures like rent banks

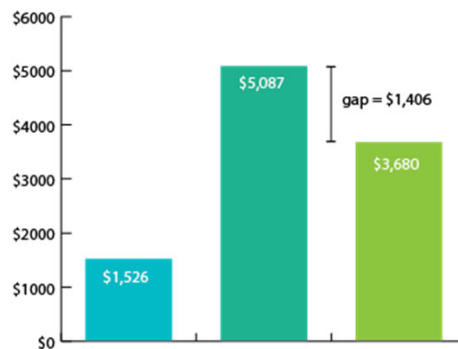

### Affordability Gap for Renters, City of Victoria, 2020

- Monthly payment for 2 bedroom private rental unit
- Monthly income needed for unit to be considered affordable<sup>1</sup>
- Median monthly income for renters (2015)  
(Based on median annual income of \$44,165)

<sup>1</sup> Monthly payment equal to 30% of monthly income

- \$110,000 is being requested from the City, for 2022 fiscal
