## ATTACHMENT RE THE DEVELOPMENT PROPOSAL FOR 515 FOUL BAY ROAD

## LEGAL/ETHICAL: THE ENVIRONMENTAL PROTECTION ACT AND DESIGNATIONS

The province's Environmental Protection Act governs the safety for Garry Oaks. These, once plentiful, are now found in a limited number of clusters, such as Foul Bay Road.. The agenda's arborist report: mentions:

- 50 assessed trees, and, of these taken out 19, (nearly two-fifths),
- 12 designated trees and 11 Garry Oaks to be removed, with 24 bylaw replacement trees.

#### Points to be noticed:

- The number of lost designated trees and oaks creates a lack of ability to keep any tree safe.
- So many removals are against the law and bylaw's spirit, as ethically wrong at least.
- Trees act as carbon sinks, so the removals release the carbon out. again.
- Three new houses with pavements cause three times removals and building process disturbance.
- If this proposal passes, it will be a large precedent for similar losses happening elsewhere.
- "Endangered" means "in danger of gone forever," so saving oaks is the priority.

#### SCIENTIFIC INFORMATION

"The arborist (under Heritage in the agenda) states that "<u>on</u>e of the principle design objectives is to preserve the mature trees and character,,. " Yet the report cautiously gives warnings, which added together bring a worrying undertone:

- The home construction and blasting as well as installation of utility services...may impact the retained trees," so mitigation work is needed. . "
- The anticipation is "that the remaining mature trees may be negatively affected over time. "
- :Rocky formations make " achieving planting sites for the replacements challenging."
- On adjacent private properties 14 trees (4 bylaw protected,) were also noted as "potentially being impacted by the construction process of the 3 single-family homes."

So many "mays" do not refer to the scientific research on removals weakening the area. Geophysicist Dr. Trevor Lewis ,on the Npbel-awarded International Panel on Climate Change, concluded in a report:

- Removal of trees causes the temperature of the soil around to rise.
- · Summer is the worst time when more water evaporates.
- In view of these facts, we should be careful since:
- Climate change could accelerate heat, so what is done now could accelerate damage.
- Stabilizing actions for buildings and paving restrict water access.
- There will very likely be an area around the site, with dying trees.

Wouldn't the replants could also be affected? Isn't the city responsible to the neighbours to keep their trees ? Do the neighbours have the right to look to the city for compensation?

Tree designations, endangered Garry Oaks and other magnificent trees, here and in the area around, should not sacrificed for 3 expensive houses and 5 short-term (even if at lower rates) rentals.
