Subject: Proposed Neighbourhood Boundary Change to Fairfield/Downtown neighbourhoods

I live within the area of the proposed boundary change from the Fairfieild neighbourhood to the Downtown neighbourhood.

I equally use all three neighbourhoods (Fairfield, James Bay and Downtown) in my daily activities including shopping, entertainment and meeting up with friends (either in their homes or in nearby shops). I shop and go for coffee along Cook Street in Fairfield and use the Cook Street community center. I also walk to James Bay to go to Thrifty's, restaurants, walks in Beacon Hill Park, or to visit friends. I also shop, eat in restaurants and wander downtown! So I'm struggling to decide to which neighbourhood I belong.

I recently made an application to the James Bay medical center for health care as it is within walking distance but I was told I am not within the James Bay boundaries despite the boundary running along my street. In this respect, I am in an area that seems neglected from consistent medical service as it hasn't been clear to me where I should seek service.

My concern with being identified with the Downtown neighbourhood is that our needs and desires as residents and property owners may be overshadowed by commercial, tourist, and business uses and in the handling of social issues. As a resident living at the fringe of Downtown, I would want a say in the continuing re-development and intensification of the Downtown area. In this regard, I am not certain if residential concerns are better supported by being within the Downtown boundaries or by a strong residential neighbourhood at the Downtown's edge.

When looking at the map and based on my knowledge of the area, perhaps a guide to division would be to look at the land uses along the streets - if the majority of buildings along the street are for residential use, keep that street within the residential neighbourhood. If the street is a mix of commercial, residential and government or business use, then it makes sense to include it in the Downtown neighborhood.

My street (Rupert Terrace) is exclusively residential. Fairfield and the south side of Burdett Streets between Quadra and Blanchard, are also exclusively residential, so I believe these streets belong within a residential neighbourhood.
