I am strongly opposed to the development of 2440 and 2448 Richmond Rd. In a neighbourhood that has no park and very limited green spaces, Adanac is a prized pedestrian corridor between Shelbourne and Richmond, 2 busy streets that confine parts of this neighbourhood to single westeast residential blocks. Prized because of its quietude, and the lovely access-pathway off Shelbourne. It may be difficult for City Council to realize how precious a short pathway and a quiet dead-end street are in a neighbourhood like North Jubilee. Shelbourne St has already been 'given' to condo development; the east side of Richmond north of Bay has also seen an increase in multi-unit development. If 2440 and 2448 go ahead, a precedent for further development along the west side of Richmond north of Bay will be set, and doubtless pursued. At which point, these single west-east residential blocks of North Jubilee will be totally hemmed in, and all sense of family neighbourhood destroyed. As I understand, City Council has expressed an active interest in enhancing the sense of community in neighbourhoods. In my opinion, the development of 2440 and 2448 Richmond Rd. will undermine this intention. The proposed multi-unit buildings are, in both scale and aesthetic, at odds with the architectural tone of homes on Adanac St. Architectural tone matters - everyone feels it. The very qualities that make this pedestrian corridor so incredibly special in North Jubilee will be lost. The last thing Richmond Rd needs is more traffic.
