I am writing to you in support of the inclusion of the Bird-Friendly Building Design guidelines that have been added to the December 2021 version of the Downtown Core Area Plan Guidelines document.

I encourage council to make bird-friendly design a requirement for all new developments, not only in the downtown core, but throughout the city. The excessive use of glass and lighting in new developments has caused unnecessary bird deaths. Fortunately, new buildings can mitigate this risk using the well-researched bird-friendly design guidelines that are becoming common place in other major cities. Additionally, it is recommended that new building proposals be reviewed by a qualified environmental professional for inclusion of appropriate bird-friendly design elements to ensure the intent of the guidelines is being implemented appropriately.
