PLEASE move forward in support of the Rapid Deployment of Affordable Housing. Our city is full of people who are either unhoused or precariously-housed.

We cannot provide shelter for more people without building more housing, and renters cannot afford to wait years for housing because homeowners are 'concerned about their neighbourhood and its character' during every proposal.

EVERY PERSON WHO OWNS LAND in Victoria has seen their property value increase SIGNIFICANTLY in the last year. What have renters seen? Huge increases in rent, and decreasing rental stock. Reasonably priced rentals receive 10s-100s inquiries within only a day or two. Competition is fierce, and more property owners report that they choose to leave their investment properties empty, or are putting their suites on AirBnB (which only further decreases the number of available rentals).

Delays in approving desperately needed affordable housing perpetuate the wealth inequity in our city. As NIMBYism postpones development, homeowners gain property value. All that renters gain are the rapidly increasing housing costs. SHELTER IS A HUMAN RIGHT, AND IF HOUSING CONTINUES TO BE AN INVESTMENT INSTEAD OF AN ACCESSIBLE RESOURCE, OUR CITY WILL COLLAPSE.

MANY jobs in our city pay minimum wage, despite our living wage requirement of more than \$25/hr. How can one expect a single adult to afford >\$1700 a month on rent alone? Who will serve and welcome our tourists when those in the service industry cannot afford to keep a roof over their head? How does a single parent afford rent and childcare? HOW DO OUR SENIORS AND VETERANS SURVIVE IF THEY ARE FORCED TO MOVE?

The population in our city is growing. We simply cannot house more people without building more housing. We cannot afford to delay and deny projects to cater to landowners now. Those fighting affordable housing are the already-housed. When we say no to affordable housing, we are saying no

to single parents, saying no to the disabled, saying no to seniors and veterans....and leaving hundreds unhoused and in deepening debt.

Pease, please approve the Rapid Deployment of Affordable Housing. Represent the huge portion of your constituents who are being priced out of their city. Represent diversity. Represent inclusion. Represent what you know is best for your community. Approve rapid access affordable housing developments NOW.

The true measure of any society can be found in how it treats its most vulnerable members. Council can make a huge impact in supporting the most vulnerable our community. The time to streamline affordable housing is now - before more of the precariously-housed lose access to shelter.
