



While we fully support harm reduction interventions, there has been a significant increase in vandalism, violence, and harassment on our block since Solid was granted their temporary permit at 1056 North Park St. This has included destruction to property costing tens of thousands of dollars, distressing encounters for the many children who live on this block (many of whom are children of refugee families who have significant PTSD), an observed increase of police presence on the block, and confrontations with people using substances on the street near Solid who behave erratically and aggressively even to those simply walking by. We've also seen an increase in people breaking into cars parked on the block and trying to break in to houses in our complex by trying doors and jumping back fences. This block of North Park is now part of a triangle of activity from Our Place to the temporary housing structures near Royal Athletic Park and the Solid Outreach service. This spreads activities out over the entire North Park neighborhood, not just this one block of North Park up for review. It would be great if Solid could be co-located with other services for those living with substance use disorder, rather than renewing Solid's current location in a residential neighbourhood.



Although we recognize the need and do support help for some of Solids/Substance abuse/safe injection site clients - I do not support the negative impact to the neighborhood. Daily, I and my staff witness people participating with the various services offered and then, once out of the building(s) are left on their own with what appears to be no thought to their condition afterwards. There are often people stumbling around dangerously close to, if not, in the roads, mainly Cook St.. Multiple times daily we have witnessed near misses with Cook St. traffic. There are daily clientele that exit the buildings and collapse on the main sidewalk (west) of Cook St.. We have not witnessed any support or assistance for these unfortunate people. They are often splayed on the sidewalk, for hours on end causing concern, to local businesses and passerby's as to whether an ambulance should be called. This activity is also witnessed not only by the local businesses/pedestrians but by the young children that attend the Oasis day care center directly opposite these sites. In addition parents of the youth that attend the Harbour Cats training facility in 1821 Cook St. have expressed concerns and are forced to accompany their children in dropping and picking up. We have also witnessed a number of aggressive confrontations/encounters by the users of the outreach facilities and local business employees and clientele. Local businesses are vandalized as a result of the negative element attracted to the area and theft is a very common occurrence. This type of support facility would be best served within/closer to the support facilities provided by the municipalities/Provincial Government.
