## F.1 <u>2615 Douglas Street: Rezoning Application No. 00680 and Development</u> Variance Permit Application No. 00247

Zoning Regulation Bylaw, Amendment Bylaw (No. 1275) - No. 22-037: To rezone the land known as 2615 Douglas Street from the S-1 Zone, Limited Service District, to the S-12 Zone, Douglas & Kings Limited Service District, to permit a brewery, distillery, brewpub, liquor retail sales and a commissary kitchen (shared commercial kitchen aimed to support small businesses and start-ups).

## Development Variance Permit Application No. 00247

The City of Victoria will be considering the issuance of a Development Variance Permit for the land known as 2615 Douglas Street for the purpose of varying certain requirements of the Zoning Regulation Bylaw – namely: to reduce the required number of vehicle parking spaces from 241 to 122 in order to permit the proposed new uses in the existing heritage-designated building, including brewery, distillery, brewpub, liquor retail sales and a commissary kitchen.
