Attention: Legislative Services & City of Victoria Engagement,

We recently received a letter Dated June23, 2022 from City of Victoria Engagement regarding consideration of potential sale of land adjacent to the Jewish Cemetery. As one of the neighbours most affected by this proposal, my wife and I are strongly opposed to the sale of this land or any other development of this green space.

This is not the first time we have been approached by the Congregation Emanu-El. March 2016, May 2020 and now June 2022. Each time the neighbours collectively have been opposed to the plans of installing a grave site for non-Jewish partners for burial at this location. We have seen the drawings with fencing up to the existing sidewalk, and samples of what the head stones might possibly look like.

When my wife and I purchased our home, we knew the boundaries of the existing cemetery and have been comfortable living here. We did not envision the possibility of the cemetery expanding to the sidewalk on the other side of Fernwood Rd., directly across from our house, or we would never have purchased the house!

Many people in the community use this green space on a daily basis. Walk their dogs, children play on the rocks and even people picnic there from apartments down the road. Besides the green space, there are Gary Oak trees, deer graze there, and certain times of the year migrating ducks appear.

In one correspondence previously from Congregation Emanu-El Cemetery) he stated living next to a cemetery does not devalue the property in the surrounding area. His information was from an American source. I contacted the BC Assessment Authority with his information and they stated that this would devalue the property values!

The area in question is mostly all rock. It would be necessary to blast for a suitable burial site. Our house sits on top of this ledge of rock and even during blasting in the existing cemetery we have cracks in our plaster.

The drawing provided in the letter by the department of Engagement does not depict the Satellite image of Cedar Hill Rd. and Fernwood Rd. It has not been like this the 38 years we have lived here. If this sale did go ahead, the value of this property to the community is priceless. The burial sites do have a value and sold according to Congregation Emanu-El web site.

There could be other options like the north part of Acton St currently used for parking, or across from Oakland's Chapel on Cedar Hill Rd. Maybe, closing Cedar Hill Rd. to Fernwood Rd could create room... of course for discussion.

We are attaching all the correspondence over the years for you to digest before making a decision. I would also encourage you and other decision makers to visit the site. See for yourselves the close proximity to our homes and ask yourself would you accept the changes they are proposing?



(See attached copy of PDF dated April 27, 2020 signed by ________) My wife and I would again, greatly oppose any changes to this green space. For the residence, it provides us with a buffer zone between the cemetery and the busy road way.

During the last visit from 2016 a site to the "Triangle" was arranged and attended by the local residents. _____assistant outlined the area and the proposal. The residents all agreed that this would **not be supported** for such a proposal.

We have lived at our address for more than 35 years, although a busy place with traffic and other functions, we enjoy having this green space looking out our front windows and the separation from the cemetery. We received your letter on Friday, explaining your intentions again of approaching the City of Victoria to acquire the land known by you as the "triangle". This is the same proposal we reviewed March 2016.

The input from the group of adjacent residents might have been helpful to you, but the unanimous decision was absolutely NO! We explained to you this was because of our reasoning, that it would decrease property values, loss of green space, and use of the land by other people of the Oakland's Area.

After this meeting, no further communications occurred and we assumed the issue was finished and completed.

As good neighbours for the past 35 years, we have provided firsthand view of things that might be of a suspicious nature (campers, drug dealing and attempted break in to your shed), and many times reported it to the authority's.

The Oakland's Community Association and its Community Association Land Use Committee (CALUC) have not approved anything with respect to the Emanu-el Congregation proposal. The OCA and it's CALUC do not approve (or disapprove) of developments in the community as this is not within our mandate. Please see the City's Terms of Reference for CALUCs for more information on the role of the CALUC in the City's development process:

Having read the letters you provided, it is my understanding that the April 27, 2020 is the initial step that the Emanu-el Congregation is taking (at their discretion) in terms of bringing this proposal forward to the City. The Oakland's CALUC would become involved if a "community meeting" (see CALUC TOR for definition) for the proposal is required by the City. If a community meeting is required the Oakland's CALUC would host one between the Congregation representatives and the neighbours of the cemetery and Oaklands community members at large and send a summary of the meeting to the City as required. I have cc'd the City Planner formerly responsible for the Oakland's Neighbourhood who should be able to forward this on to the current planner for Oaklands. My hope is that the City may provide more clarity on whether the CALUC process applies for this type of land use application and if not the City should be able to outline what process may apply in this instance.


Shortly thereafter we had very helpful discussions with some of our neighbours and appreciated hearing their ideas. At that time we decided we would not be going forward to acquire the property. We value our relationship with you and have always tried to be good neighbours, as you have been for us.

Circumstances have changed over the past four years and I am writing to advise you that the Board of Congregation Emanu-El has submitted a proposal to acquire the triangle of land from the City to meet the present and future needs of the Jewish community and its cemetery.

Our proposal is intended to enhance the neighbourhood while tying this small piece of land to the historic cemetery, already one of the largest 'green' features in the neighbourhood.

We are pleased that the Oaklands community has benefited from our maintaining the cemetery as green space for all to share as an amenity, and the triangle would continue to be publicly accessible in the same way; as you know, the cemetery is never locked.

If our proposal is approved by the City and we acquire the land, we will beautify the site with ecologically-appropriate landscaping. We have retained Cemetery designer to ensure we will have an aesthetically pleasing result. He created the design provided below so that you can have a good idea of our plans.

You will note that any gravestones in this area will be kept low so that the street view is one of enhanced plantings. In keeping with the historic fencing of the cemetery, any proposed fencing will be transparent, much like the existing fence.

As this project develops, we will proceed in cooperation with the Oaklands Community Association and the Oakland Rise Woonerf. We will do our best to ensure that what we do not only fits in but also enhances the livability of the neighbourhood and its evolving plan. We have been given permission by the City of Victoria to proceed with the first step; to assess the geology of the site using non-intrusive ground penetrating radar. Subsequently, we will report back to the City of Victoria as part of our discussion about acquiring the triangle of land. Should we be able to acquire the land, our next step will be beautification of the site. While I continue to serve as Cemetery Director I would like to introduce you to my friends, this specific proposal. Congregation Emanu-El, owner of the historic Jewish Cemetery on Cedar Hill Road, a part of the Oaklands community since 1859, would like to ask the City of Victoria for the 'triangle' of property between the cemetery and Cedar Hill Road to be given to us for cemetery use. We believe that the property has no commercial value, and there appears to be no problems in terms of underground services (see plan on page 2).

Our intent would be to initially maintain the land through grass cutting before we can raise funds to craft a fence in keeping with the historic fence that runs around our present property. We anticipate some blasting will have to be done at some time in the future as it is clear that bedrock is close to the surface in parts of the area. Overall landscaping will be in accordance with the way our cemetery has developed

We recognise that this little island of greenery is a 'park-let' in your neighbourhood. The fencing we would provide will allow for easy viewing into the cemetery,





and most of the property in this addition to the cemetery would actually return to a green and grassy state, with only vertical headstones on it and no concrete coverings of grave plots.

We have presented our plan to the Land Use Committee of the Oaklands Community Association, and that committee saw no problems with our proposal. 
