As an owner within the building at 860 View Street, I am OPPOSED to the rezoning and proposed application to build a 10 storey property at the proposed site.

This will impact upon the view, sunlight and congestion of residents nearby. A maximum 6 storey building is much preferred as higher towers create wind tunnels, bring in greater vehicle congestion and parking constraints, diminish sunlight and views for residents already facing such issues.
