#### Staff Review:

- 537 Johnson Street
- · Residences in close proximity
- Noise related to entertainment options, amplified sound, and enclosed patio area.

#### **Public Comment:**

- · Letters were sent to 574 owners and occupants
- In response, eleven letters were received which included a letter from the Downtown Residents Association (DRA); nine respondents expressed concern, primarily regarding noise impacts, and one expressed support.

## Recommendation

That Council direct staff to notify the Liquor and Cannabis Regulation Branch that Council supports the application for a new liquor primary licence with a family food service endorsement where hours are 9am to 12am daily for the interior space and 9am to 11pm Friday and Saturday and 9am to 10pm Sunday to Thursday for the 22-person enclosed patio where the total occupant load is 105 people for Friends of Dorothy located at 537 Johnson Street.
