RE: Letter of intent to transition Liquor Primary (Club) License #4231 to Liquor Primary

This letter of intent is submitted in support of the Victoria Curling Club's application to transition our Liquor Primary (Club) License to a Liquor Primary without the "Club" designation.


The Victoria Curling Club (VCC) is located at 1952 Quadra Street, in the North Park neighbourhood, and currently has a 175 person lounge located upstairs from the main lobby. Our Club designation permits us to serve primarily our curling members during the season. The current license is valid year-round, but the member restriction limits our off-season activities to those surrounding member birthdays, weddings, and other similar events.


The hours of our license permit service from 11am - 1am, 7 days a week, and we are not seeking any change to our hours of operation, nor our service area, seating capacity, floor size or restrictions. Although the license allows for sale starting at 11am, the lounge is typically only open from 6pm - 11pm most days of the week, with the exceptions of Saturday and Sunday, or for special curling events during the season.

We wish to move to a Liquor Primary License with the aim of serving the greater community, and increasing our revenue streams, particularly during the off-season, but also in the winter when activities do not conflict with our member's usage of the space. There are three main, targeted opportunities for the lounge area, not curling focused:


- 1. During the winter season, as a pre-game gathering spot prior to Royals hockey games. We are located, in effect, in the same parking lot as the Save On Foods Memorial Centre. The VCC, in addition to the lounge, has an on-site (independently operated) café, which would allow people a one-stop point to both eat dinner and socialize prior to games next door.
- 2. During the summer, as a pre or post game gathering spot prior to HarbourCats baseball games, and other community events.
- 3. For the entire year, but particularly in the summer, the VCC sees the lounge space as one that could host smaller musical acts, in keeping with the City's Cultural Spaces initiative. In order to fully allow musical acts to play the VCC lounge when there is no curling happening, and without pulling a special event permit, we must hold a Liquor Primary License. We understand that the City is looking for venues such as ours to host music, and the feeling is that the space we have, in the area we are located in, is a perfect spot, for everything from local jazz to up and coming independent acts.

The VCC has been a community hub – for curling, but also for community events such as the Times Colonist Book Sale – since 1952. Our target audience, outside of the opportunities outlined above, has not changed, by and large. We are here primarily for our membership, but we wish to be able to reach the broader community. Having a Liquor Primary License will allow to welcome everyone to our facility.
