Victoria British Columbia – Community concerns and improvements 2023 and beyond...

It is correct that the City of Victoria is one of the oldest chartered cities, incorporated as a City on August 2, 1862, under the Dominion of Canada and has the ability to introduce its own legislation. However, it is important to note that any city's ability to introduce legislation is subject to the Constitution Act, which outlines the division of powers between the federal and provincial governments, and any laws passed by a city must be consistent with these constitutional limits.

Regarding the specific issues raised in your statement, it is true that many cities face challenges related to aging populations, rising crime rates, and affordability concerns. While some of these issues may be addressed through infrastructure improvements, it may also be necessary for the city to consider changes to municipal legislation.

It is important to have open and transparent debate on these issues, and to consider the potential impact of any proposed legislation on different segments of the community. It is also important to consider how proposed legislation fits within the overall framework of laws and regulations in Canada, including those related to immigration, housing, and crime.

It is worth noting that issues related to affordability and access to transportation are often complex, and may require solutions that involve multiple levels of government and the private sector. While it may be possible for a city to introduce legislation to address some of these issues, it may also be necessary to work collaboratively with other stakeholders to find comprehensive solutions.

In summary, while the City of Victoria has the ability to introduce its own legislation, any proposed changes must be consistent with the Constitution Act and other relevant laws and regulations. It is important to have open and transparent debate on these issues, and to consider the potential impact of any proposed legislation on the community as a whole. Finding solutions to complex challenges such as aging populations, rising crime rates, and affordability concerns may require collaboration with multiple stakeholders, including other levels of government and the private sector.

My suggestion on improving transportation services for the aging community in the City of Victoria is to prioritize the safety and well-being of passengers, IE. those using taxis and chartered bus services, especially those whom may require special assistance and care.

Requiring taxi and motor coach drivers to have a valid basic certificate of first aid training is a sensible measure to ensure that they can respond appropriately in case of a medical emergency. Equipping all taxis with a basic level 2 first aid kit or better and an instruction guide is also a helpful addition to support drivers in administering first aid.

The suggestion to require level 2 first aid certification or higher for accessible taxi drivers and equipping their vehicles with Automatic Electronic Defibrillators and oxygen bottles is a more comprehensive measure aimed at accessible taxis. It ensures that passengers with disabilities or mobility issues are provided with the necessary support and care while being transported.

My proposal for drivers to pull to a safe location, come to a full stop, apply the vehicle's brakes, and assist the injured or incapacitated passenger with applicable first aid within the scope of their training before initiating a 911 call for emergency responders is also practical and shows concern for passengers' welfare.

It is important to note that implementing these measures may involve additional costs and administrative efforts. The costs would be best transferred to the carriers business license requirements should they desire to provide transportation services for profit within the corporations boundaries. Therefore, the City of Victoria would need to carefully assess the feasibility and impact of these proposals and explore ways to implement them in the most effective and efficient manner.

Overall, my suggestion demonstrates a proactive and community-focused approach to addressing the challenges faced by the aging population in the City of Victoria. It is a thoughtful contribution to creating a more inclusive and supportive transportation system.

Provincially operated services such as BC Transit would not fall into this suggestion giving they already have strict standards in place and measures to deal directly with passenger emergencies.

As you move forward with budgeting and consideration for property taxes, I want you to consider limiting property tax increases in line with the allowed rent increase for 2023 of 2%. As a property owner in Victoria with a first floor suite, I want you to know that there is no more money. As public service employees in post secondary, salaries have not increased in two years nor are increases planned anywhere near inflation. Increasing property taxes will negatively effect us and our future renters. We have intentionally kept the rent in our suite well below average rents for Victoria to keep it affordable with the modest allowable rent increase. We have no choice but to increase the rent substantially to keep in line with inflation, cost of financing, and utilities increases the next time we have new tenants.

Where do you think property owners will find the money for a 9% or even 6% increase in property taxes? We are all making cuts and making sacrifices. What cuts will the city make?

PLEASE do not raise the parking rates to decrease the property taxes! This council and the previous council have had an undeclared war on cars and parking downtown. Dozens of spots have been dedicated to “passenger zones” which are rarely, if ever, used. Allowing parking in the areas dedicated to commercial loading after 5 or 6 pm is very reasonable, and taking this away has really hurt people who need to take a car downtown. Dear Mayor Helps:

We are the strata council for the 100-unit condo complex that stretches between Douglas and Government located at 649 and 689 Bay Street. We are a large component of the neighbourhood's residential community. A commercial enterprise in the complex employs an additional 40 people or more. We write in support of recent communications you have received from businesses in the area with respect to security issues.

As you know, with the recent initiative to provide proper shelter and accommodation for the homeless or hard-to-house community, several hotels have been purchased and converted into housing. Two of the hotels (Gorge Road and Blanshard Street hotels) are approximate 1.5 kilometers to the north of our building and two of the hotels (Paul's Motor Inn and Capital City Centre) are 1 kilometer to the south of our building.

In addition to these four hotels, we are across the street from the Queens Travelodge, a few blocks from social housing in the 2900 block of Douglas Street, around the corner from the Mustard Seed Food Bank and Queen Street Bottle Depot and less than a kilometer from the Rock Bay Landing.

Our neighbourhood is at the epicentre of all these residences and services and, as such, we are bearing the brunt of the security issues related to these communities.

Our strata over the last couple of years has incurred thousands, if not tens of thousands, in costs associated with repairing damage done to our fencing, break-and-enters and vandalism. We've spent additional money upgrading cameras and installing extra security features on our doors and gates. In addition, individual homeowners personally incur the costs of the break-and-enters when their vehicles are damaged, and possessions stolen. Our parking garage has been broken into in the last several years at least a dozen times.

Daily, we experience people using our courtyard and sounding area as a place to sleep, use drugs, dispose of garbage and discard used needles. They also use our pathways as public bathrooms. It has become enough of an issue that some of the entrances (and fire exits) to our buildings are no longer usable, particularly at night, due to personal safety issues.

We do not take issue with providing housing and we agree that everyone should have a roof over their head. However, it appears that the current solution has unfairly put the cost of the safety and security surrounding these facilities on a very small area. While we are aware that housing is only the first step in dealing with the issue of the homeless and the hard-to-house community, while waiting for the next steps to happen, our neighbourhood is suffering. Many residents no longer feel safe walking outside during the day, let alone after dark and we cannot

continue to incur the repeated expense of repairing damage caused by break-ins and trespassing.

It's not just our own safety that concerns us. Members of the local community sometimes sleep in the driveways leading up to our parking garages. When this occurs, serious accidents are bound to happen if drivers aren't alert enough or the light is low. As well, because there are many hidden spots and hard-to-reach areas in and around our property, people who may be overdosing are at risk of not be seen or found.

This is the neighbourhood that the City has designated to bear the burden of housing the hard-to-house population. The City must also step up and provide security for those who live and own businesses in the neighbourhood. It is unfair for this small neighbourhood to be solely burdened with the increased financial and personal safety costs.

The police are unable to patrol this area as much as it needs to be patrolled and the current mandate of "catch and release" leaves no deterrent for criminal activity or causing public safety issues. The City, in conjunction with other levels of government, must provide a solution.


