Re: Application for extended hours of operation.

Please accept our application for extending liquor licensing hours for Artemis located at Unit 27-560 Johnson St Victoria BC V8W3C6.

With council's blessing we opened Artemis in June and have been able to set up our mark quickly in the city. We have created a unique speakeasy bar and have been attracting a lot of business from around the country as well as outside. We are requesting extended hours to serve our guests a tiny bit longer. We are not asking for any structural change or occupant load revisions.

As-is our entrance is set up to look like a bookstore and people must ask for a specific book to get in. This mitigates any concerns for the noise for our neighbours. On a daily basis we play low jazz music at approximately 65 Db and because of our location in the basement it doesn't have any major impact on noise. Our patrons tend to leave quietly, and we have not had any noise complaints until now.

Our current business hours are only from 5-12 on weekends. We are a small business and by having that extra hour at the end it will help us create additional opportunities to attract more business. As per our original promise we have created 20+ creative jobs in the field and have been paying them meaningful wages to support their living in this beautiful city. We wish to hire more people and the only way we can do that currently is by increasing our revenue by a small margin.

We want to assure council that our change for hours is only in accordance with the primary approved purpose of the business. Our request is as below.

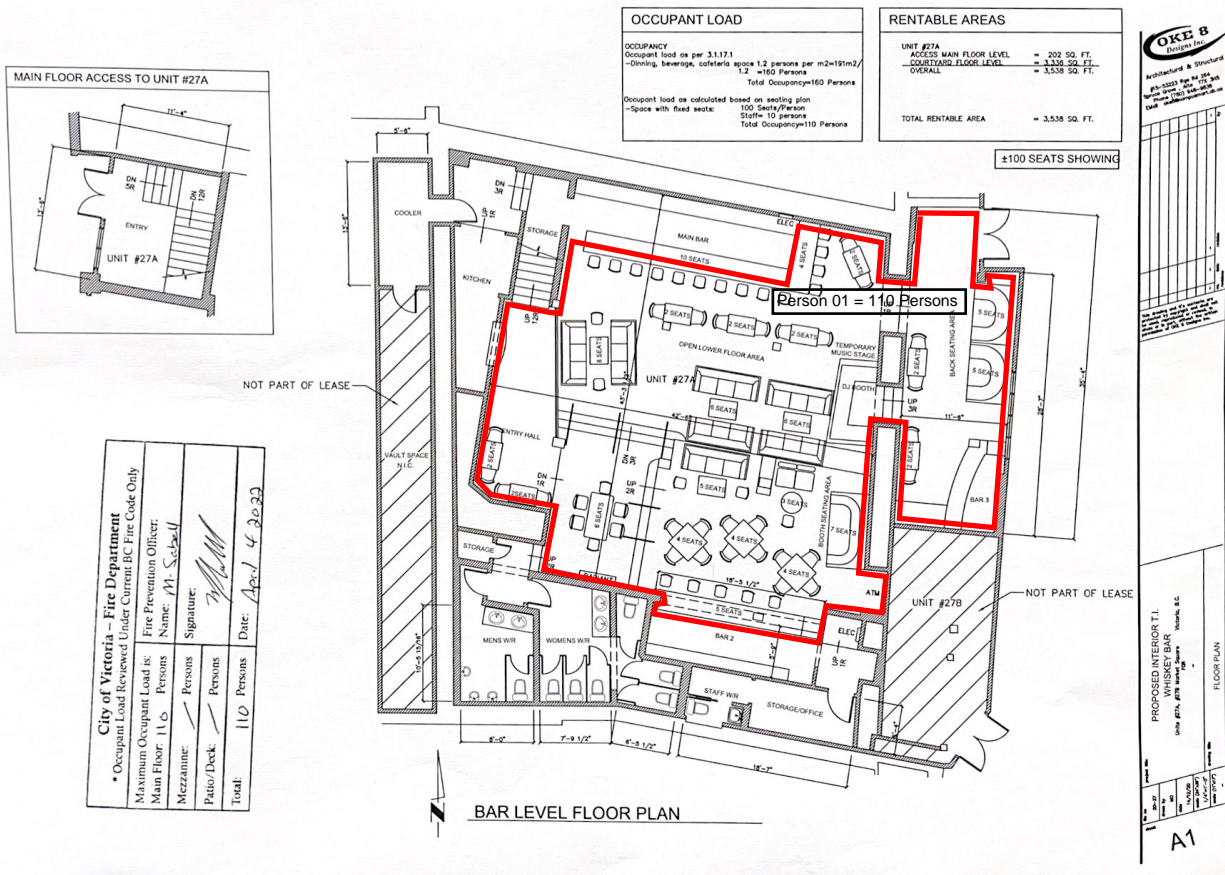
